301. Mission Bay Park Lease Revenue Statistics Update -

Presenter: Stacy McKenzie, Mission Bay Park District Manager

Ms. Stacy McKenzie, Mission Bay Park District Manager, handed out the Schedule of Mission Bay Park Lease Revenue. Ms McKenzie stated the Schedule of the Mission Bay Park Lease Revenue has been prepared for the start of FY 11 - July 2010 through February 2011.

CY cash *invoiced* is \$15,604,600. PY cash invoiced during the same timeframe was \$16,481,144.

CY cash *received* is \$16,847,655 where as PY cash received, was \$16, 937,655.

FY11 revenue for this time period is bit lower, by 6%, but it is too early to tell if revenue will trend lower for the rest of the fiscal year. There is an imbalance of revenues to invoices due to a varied method and timeframe that lease holders make their lease payments. Some of the leaseholds pay quarterly and some pay monthly. Some pay in advance and some pay late.
