INFORMATION ITEMS

501. Effective March 1, 2014 the City of San Diego will no longer issue Modified Special Event Permits, which were previously issued to authorize the use of alcohol at private events in Mission Bay Park where the use of alcohol is otherwise prohibited without a Special Event Permit. Applicants who previously applied for the Modified Special Event Permit must now apply for a Special Event Permit and shall comply with the standard terms and conditions for alcohol management described in the Special Event Permit Guide. This includes a beer

garden with either a six (6) foot free-standing fence or two (2) four (4) foot free-standing fences placed six (6) feet apart, access would be 21 years and older only and you cannot bring your own alcohol. Alcohol must be controlled by the event organizer and alcohol can only be sold or provided free of charge by designated, trained event staff.
