with Park Planning is finishing the scope of services for the three (3) year for the De Anza Special Study. There will be four (4) public workshops, two (2) this fiscal year (FY16) and two (2) in the next fiscal year (FY17).

For the De Anza Special Study, the Planning Department has requested that the Mission Bay Park Committee create an Ad hoc committee to provide input on the future workshops and the study. The Planning Department has asked that there be a combination of four (4) members of the Mission Bay Park Committee and additional non-members members to represent a diverse cross section of the Committee. Suggested non-members include:

Pacific Beach Community Planning Group Clairemont Community Planning Group Rose Creek Watershed Alliance Mission Bay Lessees Association

The four (4) Committee members will be: Paul Robinson, Chair of Ad-hoc Jim Greene Darlene Walter Cindy Hedgecock

Public comment ensued:

- o Boundaries outside the special study should be looked at
- The area needs more marsh land
- Rose Creek downstream should be considered
- Someone from Audubon Society should be included in the Ad-hoc Committee
- Sub Committee Chair from Pacific Beach Town Council should be represented
- o Campland by the Bay representative would like to be included

Mr. Robinson spoke about the meeting he had with the Mayor about the process starting with a "blank slate". He said the impression he got was to start with the special study area then add to it. He assured folks no one would be left out.

Mr. Robinson stated that due to the number of issues raised the creation of the Ad-hoc Committee will be moved to an Action Item for the November 4, 2015 Mission Bay Park Committee meeting.
