#### SUMMARY

<u>Issue</u> – Should the Park and Recreation Board recommend that the City Council adopt an ordinance as follows:

- Amend Section 56.54(b), titled "Alcoholic Beverage Consumption Prohibited in Certain Areas" and Appendix 56.54A ("24 Hour Ban") to include the following parks:
  - o Fault Line Park
  - o Cortez Hill Park (a.k.a. "Tweet Street Park")
- Amend Section 63.0120(a), titled "Nighttime Curfew for Certain Downtown Public Parks and the Spruce Street Pedestrian Bridge" to add the midnight to 6:00 a.m. curfew to include:
  - o Fault Line Park
  - Cortez Hill Park

Director's Recommendation - Recommend approval of the proposed ordinance amendments.

<u>Other Recommendations</u> – The following groups have reviewed and considered the proposed project. A summary of their actions taken and/or recommendations made by these groups are listed below.

- Cortez Hill Active Residents Group
  - Discussed the items at their April 11, 2015 meeting with approximately 50 members in attendance; no objections received
  - A letter of support is provided as Attachment C
- Downtown Community Planning Council
  - Voted 19-0 in favor of the recommended action at their meeting on April 15, 2015
  - Final Draft minutes of their meeting are provided as Attachment D
- Community Parks I Area Committee
  - Voted 9-0 to support staff's recommendation on May 6, 2015

### Municipal Code Updates Fault Line Park & Cortez Hill Meeting of May 21, 2015

- Minutes of the Area Committee meeting were not available by the date required to submit this report to the Park Board for consideration. There was little discussion on this item with unanimous support received from the CP-1 Area Committee. As the park opening is currently scheduled for August 2015, and the municipal code modification is desired to be accomplished in conjunction with that opening, staff requests that the Park & Recreation Board take action to allow the modification to be presented to the City Council for their consideration.
- East Village Association
  - Voted in favor to support staff's recommendation with the modification that the curfew for Fault Line Park be from 10:00 p.m. to 6:00 a.m. for a one-year trial because of a concern that the heavy homeless population in the immediate area was cause for a longer curfew initially, until the neighborhood contained more residents (multiple projects are in construction at this time).

Fiscal Impact - Minimal cost for new/additional signage.

Water and Energy Conservation Status - The proposed ordinance amendments comply with all water and energy conservation guidelines contained in Council Policy 200-14.

Environmental – This activity is not a "Project" for purposes of the California Environmental Quality Act (CEQA) because it does not fit within the definition of a "Project" set forth in Public Resources Code Section 21065 or State CEQA Guidelines Section 15378. The proposed ordinance would establish a curfew and the prohibition of alcoholic beverages within an existing park and a park currently under construction and does not have the potential to result in a direct or reasonably indirect physical change in the environment. Therefore, this activity is not subject to CEQA pursuant to State CEQA Guidelines Section 15060(c)(3).

#### BACKGROUND

Public parks are intended for the enjoyment of the general public including families with children. In an effort to curtail criminal activity, noise, violence, and dangerous, aggressive and offensive conduct related to the excessive use and abuse of alcohol, the City of San Diego ("City") established a 24-hour ban at a number of its parks. It has been the experience of the City that the prohibition of alcohol in City parks results in a decrease in violence and undesirable behavior. Existing Downtown parks where the 24-hour alcohol ban is in effect include, Amici Park (listed as "Washington Elementary School/Park" although this park is no longer under the City's inventory), Children's Park, Children's Museum Park, Gaslamp Square Park, and Pantoja Park.

In the mid- to late-1990s, a nighttime curfew was established in Downtown parks amid concerns of transient activities in the recently-opened Gaslamp Square Park and the new Children's Park under construction. Centre City Development Corporation (now Civic San Diego) staff met with

representatives from the Police Department, Park & Recreation Department and the City Attorney's office to discuss a number of actions to help make those parks available to all San Diegans, without intimidation by the concentration of transients in defined urban spaces.

Among the actions discussed was a curfew for not only Gaslamp Square Park and Children's Park, but for Pantoja Park and Amici Park as well. All parties agreed to proceed with establishing a curfew and on November 12, 1996, the City Council adopted Ordinance O-18357 establishing a midnight to 6:00 a.m. curfew for those four parks.

#### DISCUSSION

CivicSD staff, after discussions with City Park and Recreation staff, is proposing to extend the alcohol ban and curfew to Downtown's two newest parks – Fault Line Park and Cortez Hill Park.

Fault Line Park – A soon-to-be-completed 1.29-acre park located in East Village, this park is being constructed as part of an Owner Participation Agreement (OPA) and three subsequent Implementation Agreements between the Former Redevelopment Agency and Pinnacle International Development, Inc. ("Developer"), a California corporation (Developer's predecessor-in-interest). The OPA provides for the Developer to construct a neighborhood public park and private development on the 120,000-square-foot "super block" bounded by Island Avenue and 14th, 15th, and J streets. Anticipated completion of park improvements is in the spring of 2015 with park opening planned for the summer of 2015.

The park will lie within a perpetual park easement, as well as over a portion of the private development's subterranean parking garage constructed as part of the first phase of the Developer's mixed-use residential project. The park is located on the western half of the super block and includes large turf areas, a playground and tot lot, boulders and rolling topography, shade trees and trellises, benches and seat walls, intimate garden areas, public art, and joint-use public restrooms in an adjacent corner commercial structure, currently home to Stella Public House and Halcyon restaurants. The Developer, along with its successors, is obligated to maintain the completed public park and joint-use public restrooms in perpetuity through a Park Maintenance Agreement with the City.

Cortez Hill Park – Opened in 2008, Cortez Hill Park is located along the north side of Date Street between 7<sup>th</sup> Avenue and 10<sup>th</sup> Avenue and along the east side of 10<sup>th</sup> Avenue between Date Street and Beech Street. It is a narrow, 1.68-acre linear park and contains curved walking paths, a play area for small children, benches, pedestrian-scaled lights, litter receptacles and pet rest area facilities. Trees, shrubs and groundcovers were included in the park design, as well as a small portion of lawn near the play area. The park is often referred to as "Tweet Street" as it features a bird-oriented theme.

The purpose of these amendments is to allow Fault Line Park and Cortez Hill Park to be in-line with other downtown parks with regard to alcohol usage and hours of operation. The ban on alcohol minimizes potential raucous behavior and provides for a safer environment for general public use. The 24-hour alcohol ban is currently effectuated in existing Downtown parks, with

the exception of Cortez Hill Park. Alcohol consumption in these parks would still be allowed through the issuance of a special event permit from the City. Concern over homelessness and illegal activities in parks had caused the implementation of a midnight to 6:00 a.m. curfew on existing parks. The curfew provides a means for the Police Department to be able to clear out the parks in the late hours to minimize the parks' use for criminal or unsanitary activities and further emphasizes the prohibition of overnight camping.

#### **ALTERNATIVES**

- 1. Recommend approval of the proposed alcohol ban and curfew with modifications.
- 2. Do not amend San Diego Municipal Code Section 56.54(b) and Appendix 56.54A or Section 63.0120(a).

(b) Definitions. Whenever in this section the word "nude" is used, it shall mean devoid of an opaque covering which covers the genitals, pubic hair, buttocks, perineum, anus or anal region of any person, or any portion of the breast at or below the areola thereof of any female person.

Whenever in this section the term "public right of way" is used, it shall mean any place of any nature which is dedicated to use by the public for pedestrian and vehicular travel, and includes, but is not limited to, a street, sidewalk, curb, gutter, crossing, intersection, parkway, highway, alley, lane, mall, court, way, avenue, boulevard, road, roadway, viaduct, subway, tunnel, bridge, thoroughfare, square, and any other similar public way.

- (c) Nudity Prohibited. No person over the age of ten years shall be nude and exposed to public view in or on any public right of way, public park, public beach or waters adjacent thereto, or other public land, or in or on any private property open to public view from any public right of way, public beach, public park, or other public land.
- (d) The provisions of this section shall not apply to live theatrical performances performed in a theater, concert hall, or other similar establishment located on public land. As used in this section, theater, concert hall or similar establishment means a building, playhouse, room, hall or other enclosed place not open to public view from any public right of way but having a stage upon which movable scenery is located and theatrical, vaudeville or similar performances are given and seats so arranged that a body of spectators can have an unobstructed view of the stage and whose primary function is to give such performances.

#### §56.54 Alcoholic Beverage Consumption Prohibited in Certain Areas

(a) Definitions. For purposes of sections 56.54, 56.55, and 56.56, the following terms are defined as follows:

*"Alcoholic beverage"* has the same meaning as that set forth in California Business and Professions Code section 23004.

*"Bather"* has the same meaning as that set forth in California Harbor and Navigation Code section 651.1.

"Beach" means the sand or land area bordering the water of an ocean or bay.

"Marine league" means three nautical miles.



#### ATTACHMENT A

*"Public park"* means any property designated, dedicated or developed by or on behalf of the City of San Diego for park or open space use.

"Seawall" means any wall between the beach and the boardwalk.

"Sidewalk cafe" has the same meaning as that set forth in San Diego Municipal Code section 141.0621.

"*Vessel*" has the same meaning as set forth in California Harbor and Navigation Code section 651(aa).

- (b) Unless the City Manager or designee has issued a special event permit, or unless otherwise permitted by section 56.54, it is unlawful for any person to consume any *alcoholic beverage* at any time, upon any public property, not including *public parks* and *beaches* except as specifically listed in Appendix 56.54A, and public rights-of-way, including but not limited to public streets, parking lots, sidewalks, alleys, plazas, piers, including on or against *seawalls*, and including all sidewalks along the outer perimeters of such areas.
- (c) 12 Hour Ban

It is unlawful to consume alcohol in the areas listed in Appendix 56.54B between 8:00 p.m. and 8:00 a.m., unless the City Manager or designee has issued a special event permit or unless otherwise permitted by Section 56.54.

(d) 16 Hour Ban

It is unlawful to consume alcohol in the areas listed in Appendix 56.54C between 8:00 p.m. and Noon, unless the City Manager or designee has issued a special event permit or unless otherwise permitted by Section 56.54.

- (e) Section 56.54 does not prohibit:
  - (1) any person from consuming *alcoholic beverages* within the defined boundaries of a *sidewalk cafe* located on the public right-of-way, or on property leased from the City.
  - (2) any business from lawfully selling or dispensing *alcoholic beverages* in accordance with the requirements of local and state law.
- (f) Notwithstanding any other provision of section 56.54 and its appendices, and except as provided in section 56.54(g), it is unlawful for any person to consume any *alcoholic beverage* at any time, upon all public *beaches*, including any sidewalks, boardwalks, alleys, plazas, piers, jetties, on or against *seawalls*, upon public rights-of-way at any *beach* or coastal bluff, and all coastal access, view point and bluff rights-of-way, and including the adjacent coastal *public parks* and areas listed below:

# §63.0120 Nighttime Curfew for Certain Downtown Public Parks and the Spruce Street Pedestrian Bridge

- (a) It is is unlawful for any person to be on the grounds of the following parks from midnight until 6:00 a.m.: Children's Park, Gaslamp Square Park, Pantoja Park, Amici Park and the Children's Museum Park.
- (b) It is unlawful for any person to be on the Spruce Street Pedestrian Bridge from 10:00 p.m. until 6:00 a.m.

(Retitled from" Nighttime Curfew for Certain Downtown Public Parks" to "Nighttime Curfew for Certain Downtown Public Parks and the Spruce Street Pedestrian Bridge" and amended 11-27-2000 by O-18891 N.S.) (Amended 7-31-2009 by O-19891 N.S; effective 8-30-2009.)

#### §63.0130 Periodic Temporary Park Closures

- (a) As used in Section 63.0130, *turf area* means: an area of grass, which may also include dirt or soil, maintained for recreation or recreational activities.
- (b) Subject to Section 63.0130(c), and in accordance with policies and procedures for *turf area* closures as adopted by the City Manager and as amended from time to time, the City Manager shall close for renovation and maintenance the *turf areas* of the upper field at Allied Gardens Community Park, the Lower Lewis Middle School joint-use area, and Skunk Hollow, for at least thirty consecutive days each between May 1<sup>st</sup> and August 31<sup>st</sup> of each year, which areas are more specifically shown on the map on file with the Office of the City Clerk of the City of San Diego as Document No. 00-19175. Closure of these *turf areas* shall be determined by the City Manager and shall be staggered so that only one *turf area* is closed at a time.
- (c) Any *turf area* subject to a joint-use agreement or lease shall be closed only if the closure is in compliance with the terms of that joint-use agreement or lease, and only with the consent of any other party to the joint-use agreement or lease.

- Variance: The unbuildable portion of the site, due to the fault line, is not being considered in the FAR calculations. Parking on this site in extremely difficult due to fault-line and is trying to adhere to the Downtown PDO.
- Public Speakers (in favor): Rob Morgan, Jeff Svitak & Joshua Lichtman (applicant team) marketed at students, design attempts to create a sense of community among residents, importance of light and fresh air, entire front façade is patios to create soft edge, commercial space can be opened to street. Gary Smith (neutral) where will people go with their cars? Don't be swayed by student housing, these are market rate. Colin Parent, Circulate San Diego we love this project because it incorporates Carto-Go and public transit; millennial's are looking for housing and work opportunities that eliminate the need for a car. Marcela Escobar this is the type of project our children are looking for, they have provided alternative transportation methods.
