# **Background**

#### P&R FY 2015 General Fund:

**Expenditures** \$97,970,148

Revenue \$32,708,616

- Current revenue from user fees or use of government property: \$5.3 Million
- \$5.25 Million in additional revenue identified in the Fee Study from user fees if at full cost recovery
- Recommended fees will result in an additional \$278,836 in revenue

#### **Proposed Fee Reductions**

- Some reductions are mandatory per Proposition 26
- Some reductions are proposed based on market comparisons

#### Proposed Fee Increases

- Some increases are based on the cost to provide the service
- Some are based on market comparisons

#### **Proposed New Fees**

#### 17 New Fees

- Adult Athletic Field and Court Reservations for Leagues
- Boat Rental
- Registration/Reservation Transaction and Credit Card Fees

#### **Proposed New Fees (cont.)**

- Vase Installation Fee for Mount Hope Cemetery
- Overtime Fee for Mount Hope Cemetery

#### **Proposed Converted or Restructured Fees**

- Removing Non-resident rates (rates will be the same as resident)
  - Excludes Mount Hope Cemetery Lots
- Removing Non-Profit with Admission Charge (rates will be the same as Non-Profit with No Admission Charge)

#### Proposed Converted or Restructured Fees

- Pool rentals for meets, games and practices converted to a per lane rental
- Swim lesson class sizes restructured
- Adult Fitness Camps revised
  - Maximum of 30 hours per week per venue per permit

#### **Eliminated Fees**

- Leased Sites
  - Balboa Park Puppet Theater
  - Balboa Park Spanish Village
- Youth Swim team
  - 10 hours per week

### **Eliminated Fees (cont.)**

- Mount Hope Cemetery
  - Recording Fee
  - Quitclaim Fee
  - Late Fee

#### Miscellaneous Changes

- Balboa Park Room Rentals
  - Fees displayed as hourly
  - Fees restructured based on size and amenities
- Balboa Park Unattended Display
- Format and Clarifying Language

#### Miscellaneous Changes

- Mount Hope Cemetery Low Income Assistance Program
  - Property value increased by 19% (from \$2,000 to \$2,380)
  - Recording fee eliminated

# **Impacts to Users**

- Impact will vary depending on the fee, size of groups/leagues, number of hours/days, nonprofit status, etc.
- Discount/Assistance programs will continue
  - Low Income Fee Waiver
  - Scholarships
  - Youth
  - Senior
  - Disabled

- Email notices to various users March 13 through March 17
- Notices mailed to Mooring and Beach Bar users week of March 16
- Anticipate Budget and Finance Committee meeting in April
