Appeal of the Hearing Officer's decision to approve an application for an after the fact Coastal Development Permit and Site Development Permit for emergency work performed in May 2010 and the planned revegetation of the slope related to the emergency work. The emergency work installed a concrete headwall to dissipate water flow and replaced portions of the existing pipeline. The project is located approximately 60 feet down slope from 7435 Caminito Rialto in the SF Zone of the La Jolla Shores Planned District, within the La Jolla Community Plan Area, Coastal Overlay Zone (Non-Appealable Area 2), and the Coastal Height Limitation Overlay Zone. AT&T Mobility – Rancho Bernardo Community Park LTE – An application to modify an existing Wireless Communication Facility (WCF) consisting of two 72-foot high ball field light standards with a total of twelve antennas attached. The equipment associated with this project is located inside an expanded enclosure, designed to match the park's restroom facility. A Planned Development Permit is required for the deviations to exceed the 250-square foot equipment limitation per Land Development Code Section (LDC) 141.0420(g)(3) and to continue to operate with an above ground equipment enclosure in a dedicated City park per LDC Section 141.0420(i)(1)(B)/ This project is located in the OP-1-1 (Open Space) zone and requires a Conditional Use Permit Per LDC 141.0420(f)(3). A Neighborhood Use Permit is required per Land Development Code Section 141.0420(d)(4). This project is located at 18448 West Bernardo Drive in the Rancho Bernardo community planning area in the Rancho Bernardo Community Park. This project was evaluated against the California Environmental Quality Act (CEQA) State Guidelines and was determined to be exempt. Report No. – PC-12-032

ITEM – 11: TOWERCO CITY HEIGHTS – PROJECT NO. 224500

TowerCo City Heights – A Planned Development Permit for an existing Wireless Communication Facility (WCF) consisting of a 32 foot tall monopalm. The project is located at 4735 Myrtle Avenue in the CUPD-CU-1-2 zone within the City Heights Community Planning area. There is a total of twelve antennas installed on the monopalm alongside the associated 200 square foot prefabricated enclosure. The monopalm as designed exceeds the 30 foot height limit and extends into the required rear yard setback. The equipment enclosure as design also encroaches onto the rear

and side yard setbacks. The project was exempt from CEQA pursuant to Article 19, Section 15301. Report No. – PC-12-037.

ITEM – 12: AMENDMENTS TO THE OUTDOOR LIGHTING REGULATIONS

City Council District: All Plan Area: Citywide

Amendments to the outdoor lighting regulations including Land Development Code Section 142.0740 and Chapter 14, Article 10 relating to local adoption of the California Green Building Regulations to reduce light pollution. The City's outdoor lighting regulations in Section 142.0740 of the Land Development Code are intended to minimize light pollution, promote lighting design that conserves electrical energy, and provide adequate lighting for public safety. The problem is that the City's existing regulations. Limit lighting along private walkways, roadways, and parking lots after 11 pm to low pressure sodium, high pressure sodium or light with fewer than 4,050 lumens, which has resulted in a dark environment for these facilities instead of the intended secure environment for public safety, and has prevented use of more preferable energy efficient options in conflict with General Plan goals. The proposed amendments will allow for use of some broad spectrum lighting alternatives with better color rendition for safety and better energy saving technology for consumers. Proposed limits on color temperature and the amount of up-light allowed by new outdoor light fixtures would reduce light pollution beyond what is allowable under the existing regulations. Ordinance exceptions provide flexibility downtown to support its night time commercial/entertainment activity and unique urban design goals in accordance with adopted land use plan policies and planned district ordinance regulations. The proposal also includes adoption of a new local lighting zone map to facilitate implementation of state and local requirements. The CEQA Guidelines Section 15162 analysis concluded that no subsequent EIR or other environmental document is needed as all impacts were adequately addressed and disclosed in Land Development Code EIR No. 96-0333. ITEM – 13: SPRINT INGRAHAM – PROJECT NO. 244423

City Council District: 2 Plan Area: Pacific Beach

Sprint Ingraham – A Conditional Use Permit (CUP) to modify an existing Wireless Communication Facility (WCF) located at 3866 Ingraham Street within the RM-3-7 zone of the Pacific Beach Community Plan. Sprint is proposing to relocate two sectors of antennas (a total of six) behind existing Fiberglass Reinforced Panel (FRP), painted and textured to match the existing apartment complex. The 3rd sector of antennas facing the west elevation will continue to operate without any changes. The existing equipment will also be relocated inside an existing three-sided rooftop cupola, not visible to the public. Sprint's modification for this project would result in a complete stealth WCF. The project was exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301 (Existing Facilities) and 15303 (New Construction). Report No. – PC-12-040
