Amendments to the Centre City Planned District Ordinance (Chapter 15, Article 6, Division 3) and Local Coastal Program (LCP). The amendments address a variety of topics including, but not limited to, land use, permit process, development regulations including an increase in the required amount of pet open space and modifications to regulations pertaining to roof-top mechanical screening, separately regulated use regulations including amendments to provisions related to live entertainment, on and off-premise alcohol sales and outdoor activities and refinements resulting from recently approved city-wide municipal code regulation amendments. The amendments also include several clean-up items including edits to text and corrections to figures.

This project is covered under the Final Environmental Impact Report (FEIR) for the Downtown Community Plan, CCPDO, and 10th Amendment to the Centre City Redevelopment Plan, certified by the Former Redevelopment Agency ("Former Agency") and City Council ("Council") on March 14, 2006 (Resolutions R-04001 and R-301265, respectively) and subsequent addenda to the FEIR certified by the Former Agency on August 3, 2007 (Former Agency Resolution R-04193), April 21, 2010 (Former Agency Resolutions R-04508 and R-04510), and August 3, 2010 (Former Agency Resolution R-04544). The FEIR is a "Program EIR" prepared in compliance with California Environmental Quality Act (CEQA) Guidelines Section

15168. The proposed CCPDO amendments do not result in any new environmental impacts that were not already addressed in the FEIR or addenda to the FEIR. In accordance with CEQA Guidelines Sections 15162 and 15168, no further environmental documentation is required with respect to the proposed CCPDO amendments. Report No. PC-13-107
