- 1. Update on freeway widening, particularly the project features that will impact Greater Golden Hill and neighboring communities. The project proposes to construct Express Lanes along SR-94, one in each direction, from Interstate 5 to Interstate 805 and a direct connector at I-805. The project includes several alternatives with various impacts to Golden Hill, including closure of certain freeway ramps resulting in diversion of traffic onto existing streets, construction of a 'flyover' connector resulting in noise and visual impacts, loss of landscape buffers, construction timing etc.
- 2. Update on plans for community enhancements. Enhancements are additional project features intended as community benefit beyond required environmental mitigation and could include new pedestrian, bicycle and park facilities or improvements to existing facilities.
