March Elections: There are 11 seats up for election and 4 vacancies to fill. Census tracts and open seats are 86.0 (1), 87.01 (3), 88.0 (2), 89.01 (2), 90.0 (2), 91.06 (3) and 91.07 (3). Two members have served more than 8 consecutive years and must receive 2/3 approval.

Temporary Height Limit of Residential Dwellings: LVPG has been asked to explore the issue of adopting a height limit for its community plan in residential neighborhoods. Such a change would limit ministerial approval and require planning group review of dwellings above two stories.
