Item #001 – Information Item- Rachel Hiner Representing: Urban Food Network will give a presentation San Diego Municipal Code Section 42.0709 (Appendix “A”) that presently allows city residents to maintain up to 25 chickens, including roosters, within city limits, but requires that they be kept a minimum distance of 50 feet from any structure used for residential purposes, including the owner’s own home. She will seek community input to amend this municipal code on how to make it less restrictive.
