JULY 28, 2010 MEETING MINUTES

Agenda & Minutes: Chris Olson motioned to adopt the meeting agenda for the evening, Scott Chipman seconded, motion **passed 9-0-0**. Diane Faulds motioned to approve the June 2010 minutes, Greg Daunoras seconded, motion **passed 5-0-4**. Those abstaining did not attend the June 2010 meeting. Due to several PBPG members going on summer vacation, Leigh Gibson motioned to cancel the August 2010 Pacific Beach Planning Group meeting, Scott Chipman seconded, motion **passed 9-0-0**.

Chair's Report: John Shannon discussed the idea of working more closely with the Pacific Beach Town Council in order to further improve the Pacific Beach community for both residents and business owners. The future of Floatopia events was discussed as the City Council is preparing to vote on the issue.

Mr. Bill Harris from the San Diego Storm Water Department discussed improvements being planned for local pump stations in order to reduce the pump failures of the past winter from repeating. Mr. Harris took questions as well.

Jerry Hall suggested volunteers are needed to enroll in a city code compliance training program to be the eyes and ears of the community. Lou Cummings asked the PBPG to write a letter to the Pacific Beach Town Council to move the oversized vehicle problem from the pending box to the action box.

Amber Starbuck, SDGE's Outreach Education Manager provided a presentation on the what, why and future benefits of new digital smart meters as part of the state's energy action plan. Ms. Starbuck provided several handouts and took questions.

Rory Allen, Stacey Karras and Sarah Devine from San Diego Coastkeeper requested and moved that the Pacific Beach Planning Group write a letter to the San Diego City Council to oppose the 20-year Master Storm Water System Maintenance Plan. Chris Olson motioned to approve the project, Jim Morrison seconded, motion **passed 10-0-0**.
