Construct 5 levels of parking with 338 spaces (Accessible, Motorcycle, Bicycles, Car pool, Zero Emissions). Proposed building height is approximately 69 ft (+8 ft for elevator tower). 4575 Camino de la Plaza (APN 666-400-10-00) in the CT-2-3 zone of the San Ysidro Implementing Ordinance.

The ground floor will have retail spaces, with parking for the retail on the 1st floor, other floors are commercial parking spaces. Roof will be screened with recycled PVC netting. Project will have enough points for LEED Silver designation. The project will have a fabric design wall on the Virginia Ave side. Applicant is offering the shear wall on the Las Americas side for suggestions as a a community art project.
