Community Forum / Announcements:

- 1) Barbara Ryan gave an update on the Traffic improvements that have occurred or are planned to occur in the near future in the Birdland area near children's hospital.
 - a. Dicken requested that the traffic issues be studied and there is still an option for an additional turn lane a health centre drive. No mention of removing a southbound lane on Annrae.
 - b. Other members of the audience voiced their concerns that the parking problems improved temporarily, but have now worsened.
- 2) James Feinberg regarding Sandrock Gas station
 - a. James visited Sandrock Gas and they withdrew the application for liquor sales and are getting prepared to sell gas in the near future. Trenching in progress and the Neighborhood Code Compliance officer has visited and corrected the number of parking spaces and are working on a solution for the back bay service area.
- 3) Graffiti on storage tanks near Guild property
 - a. D. Wescott will follow up with the owners of the guild and former 76 Gas Station to address the issue.
- 4) Road Repairs
 - a. Community concerns were voiced about the state of road repairs and what standards exist when roads are repaired. D. Wescott informed community that there is a website through the city:
