- ITEM 1 DISCUSSION/POSSIBLE ACTION ITEM: Medical Marijuana Dispensaries –Motion required by City Council-Dennis Ridz – 55 minutes

ITEM 1A DISCUSSION/POSSIBLE ACTION ITEM: PERMITTING process for dispensing cooperatives and collectives – Dennis Ridz

Possible Motion: The Torrey Pines Community Planning Board recommends that dispensing cooperatives and collectives must obtain a use permit through **Process Level 3** as described in Chapter 11 of the San Diego Municipal Code for dispensing cooperatives and collectives with less than 100 members and dispensing cooperatives and collectives with more than 100 members must obtain a use permit through **Process level 4** as described in Chapter 11 of the San Diego Municipal Code.

Furthermore, all existing licensed dispensaries must comply with the new ordinances and there will be no 'Grand Fathering ' of like dispensaries whether deemed legal or not.

ITEM 1B DISCUSSION/POSSIBLE ACTION ITEM: ZONING of Dispensing Medical Marijuana Collectives and

Cooperatives – Dennis Ridz

Possible Motion: The Torrey Pines Community Planning Board recommends that dispensing cooperatives and collectives be allowed **to locate ONLY** in the following zones under the City of San Diego Municipal Code: Industrial –Park (IP), Industrial –Light (IL) and Industrial – Heavy (IH). Furthermore, dispensing cooperatives and collectives should be excluded from Commercial – Neighborhood (CN) and Commercial-Community (CC) zones within the Torrey Pines community planning area.

ITEM 1C DISCUSSION/POSSIBLE ACTION ITEM: DISTANCE requirements to be placed on Dispensing Medical

Marijuana Collectives and Cooperatives –Dennis Ridz Possible Motion: The Torrey Pines Community Planning Board recommends that dispensing cooperatives and collectives within the Torrey Pines Community shall not be located within a <u>1,000 foot radius</u> of schools, playgrounds, libraries, child care facilities, youth facilities, including but not limited to youth hostels, youth camps, youth clubs, etc., **community parks and places of religious worship.** Furthermore, dispensing cooperatives and collectives within the Torrey Pines Community shall not be located within **1,000-foot radius** of other dispensing cooperatives and collectives.

ITEM 1D DISCUSSION/POSSIBLE ACTION ITEM: Not-for-Profit Operation requirements to be placed on Dispensing Medical Marijuana Collectives and Cooperatives –Dennis Ridz

Possible Motion: The Torrey Pines Community Planning Board recommends that the City require dispensing collectives and cooperatives to submit, as part of their application for a conditional use permit (CUP), evidence that they are incorporated as statutory cooperatives or bona fide nonprofit corporations. **Furthermore, as part of the City application process, the San Diego City Police Department or similar agency should perform a Criminal Background Check. Said background check(s) should include all principals, owners or financial backers, and employees of dispensing collectives and cooperatives.**

ITEM 1E DISCUSSION/POSSIBLE ACTION ITEM: FISCAL CONSIDERATION

Possible Motion: The Torrey Pines Community Planning Board recommends that the City require dispensing collectives and cooperatives to pay their fair share of fees related to the City of San Diego's police and law enforcement costs related to the background checks, code enforcement and other actions the City deems necessary to guard the public welfare. The establishment of medical marijuana collectives and cooperatives should be revenue neutral to the City.

ITEM 1F DISCUSSION/POSSIBLE ACTION ITEM: Security requirement to be placed on Dispensing Medical Marijuana Collectives and Cooperatives –Chair Ridz

The Torrey Pines Community Planning Board recommends that the City of San Diego require medical marijuana cooperatives and collectives to have adequate and operable security systems that include security cameras and alarms and must have a licensed security guard to be present at all times during business hours.
