LEGACY INTERNATIONAL CENTER (LIC) - Informational Presentation by Mike Harrah, Caribou Industries, about the proposed LIC that will redevelop the existing Mission Valley Resort Hotel site with commercial, recreational, timeshare, administrative, and faith-based uses on an approximate 18.1 acre site. The site is located within the Mission Valley Community Planning Area south of I-8 at 875 Hotel Circle South. More specifically, the applicant seeks approval for a Site Development Permit and Planned Development Permit (Process Five) to demolish the existing Mission Valley Resort Hotel structures and parking lots and construct a mixed use project consisting of approximately 30,000 square feet of theater and museum space, approximately 127 timeshare units, approximately 23,000 square feet of office space, approximately 15,000 square feet of retail space, approximately 10,000 square feet of restaurant space, and a five level parking garage within a total building area of approximately 598,000 gross square feet and other site amenities such as: a fitness and recreation facility, a welcome center, a spa and salon, a learning center, an outdoor amphitheater, a television studio and theater, swimming pool, spa, and outdoor recreation amenities, hiking trails, a linear park, courtyard, water features, and other accessory uses and amenities.
