<u>Staff Recommendation</u>: Designate The Luscomb Building located at 1797 San Diego Avenue as a historical resource with a period of significance of 1927 under HRB Criterion A. The designation shall exclude the two-story building at the south end of the lot constructed in 1932 and addressed at 1769 San Diego Avenue.
