He was incarcerated in March, 2006 and was serving a six year prison sentence for a drug offense. David Griffis has in intensive criminal record, is a third striker, and is described as being very violent. David Griffis is known to frequent Hillcrest, Balboa Park and the beach areas of San Diego.
TIPLINE (888) 580-TIPS	David Kevin Griffis also uses the name Bryce Brian Griffis. He is a 40 year old white male about 5'9" tall and weighs about 190 lbs. He has brown cyes, a shaved head and may be clean shaven. Griffis has several tattoos. The name "Shelly" is tattooed on his neck and upper back. He also has a cartoon character and the word "hate" on his neck.
