CARS FOR SALE ON DESIGNATED CITY STREETS – NEW ORDINANCE

(San Diego) Beginning July 25, 2009 it will be unlawful to park a vehicle for sale on designated streets within the city of San Diego. However, the SDPD will provide a 30-day warning period to allow the public to become familiar with this new ordinance. SDPD will begin issuing citations to violators on September 5, 2009.

San Diego Municipal Code 86.23.1(b) reads *“It is unlawful to park a vehicle on a street designated pursuant to Section 86.23.1(e) when, because of a sign or placard on the vehicle, it appears that the primary purpose of parking the vehicle at that location is to display to the public that the vehicle is for sale.”* Cars in violation of this section will be issued a citation and a warning notice listing the designated streets in the ordinance. The notice can be found on page two of this news release.

Each parking citation issued to a vehicle in violation of this ordinance carries a \$50 fine. Vehicles in violation can receive two citations per day if the car is not moved. In addition to a parking citation, cars for sale may be impounded even if they are moved to another prohibited street, as long as the car has been cited for the same violation with the last 30 days but not within 24 hours of the first citation.

VEHICLE SALES WARNING NOTICE



Your vehicle is in violation of SDMC 86.23.1(b), PARKING A VEHICLE ON A PUBLIC STREET THAT PROHIBITS VEHICLES FOR SALE.

An additional parking violation under this Section may result in the impoundment of your vehicle pursuant to California Vehicle Code Section 22651.9(a), even if you move your vehicle to another prohibited street.

The following streets prohibit parking to advertise to the public the private sale of your vehicle.
