## **Robbery Suspects Caught on Tape** **Up to \$1,000 Reward Offered**

February 12, 2009

**San Diego County Crime Stoppers** is joining forces with the San Diego Police Department Robbery Unit to help identify and apprehend four suspects responsible for robbing a McDonald's in the San Carlos area of San Diego.

*Detectives said on February 8, 2009, at about 9:50 p.m., three black males and one Hispanic female robbed the McDonald's restaurant at 8770 Lake Murray Blvd. in San Carlos. The store clerks along with numerous customers were threatened with a shotgun but were not injured in the incident. The suspects left with an undisclosed amount of cash. A store surveillance camera captured all four suspects on video.*

Suspect descriptions:

- #1 Suspect: Black male, 20-30, 5'9"- 6' tall, 180-200 lbs. He wore a black hooded sweatshirt, black gloves, black pants, white shoes. This suspect was armed with a shotgun.
- #2 Suspect: Black male, 20-30, 5'9"- 6' tall, 190-200 lbs. He wore a black hooded sweatshirt, dark gloves, black pants, and black shoes.
- #3 Suspect: Hispanic female (or possibly Filipino or Black), 20-30, 5'2"- 5'6" tall, 120-130 lbs. She wore a grey hooded jacket or sweatshirt, black gloves, black pants, black shoes.
- #4 Suspect: Black male, 20-30, 6'- 6'3" tall, 190-220 lbs. He wore a black hooded sweatshirt, dark gloves, blue jean pants, black shoes.

*A copy of the store surveillance video is available today at the SDPD headquarters front counter, 1401 Broadway until 5 p.m. Pictures of the suspects can be found on page two of this release.*

Detectives are asking anyone with information on the identity and location of these suspects to call the **Crime Stoppers anonymous tip line** at **(888) 580-8477**. Crime Stoppers is offering up to a \$1,000 reward to anyone with information that leads to the arrest of the persons responsible for this crime.
