



# INFORMATION SOUGHT ON THE TEN-YEAR ANNIVERSARY OF ANDREW MOORE'S MURDER

**\$56,000 Reward**

Release Date: Wednesday, September 8, 2010

**San Diego County Crime Stoppers** and the San Diego Police Department's Homicide Unit continue to look for leads in the unsolved homicide of Andrew Moore. September 8, 2010 marks the ten-year anniversary of Andrew's death.

*The crime occurred on September 8, 2000. Andrew Moore, a City College student, was murdered in his apartment on Eighth Avenue in San Diego. As part of the crime, his 1994 Suzuki Katana motorcycle was stolen. The motorcycle was recovered on October 17, 2000, in the 1100 block of 24<sup>th</sup> Street. San Diego Police Department homicide detectives have not yet identified the suspect(s) in this case and are asking for the community's assistance.*

Every year Andrew's mother and father fly from Pennsylvania to San Diego to help pass out flyers in the community in an attempt to identify the person(s) responsible for the murder of their son.

**Mr. and Mrs. Moore will be available for interviews today at 10:00 A.M. at the San Diego Police Department Headquarters Broadway side front entrance.**

Anyone with information on the identity or location of the suspect(s) responsible for this case is asked to call the Crime Stoppers anonymous tip line at (888) 580-8477. Crime Stoppers is offering up to a \$1,000 reward and the Moore family has offered a \$5,000 reward to anyone with information that leads to the arrest of the suspect(s). The Governor's office has offered a \$50,000 reward to anyone with information that leads to the arrest and conviction of the suspect(s). Collect calls are accepted and callers may remain anonymous.


