



## Detectives Looking for Leads to Help Identify and Locate an Unknown Suspect Wanted for a Pedestrian Robbery

Up to \$1,000 Reward Offered

San Diego County Crime Stoppers and investigators from the San Diego Police Department's Central Division are asking for assistance from the public to help identify and locate an unknown suspect wanted for a pedestrian robbery.

*Detectives said on May 14, 2011, at approximately 2:10 p.m., a 73-year-old female victim was walking home near 310 Market Street in San Diego. The victim, who uses a walker to get around, had her purse strapped around her walker. The suspect approached the victim from behind as she made her way up the ramp to the front door of the Lions Manor Resident Home. The suspect was holding a knife in his hand and threatened to stab the victim if she didn't hand over her money. The suspect reached into the victim's purse and removed the victim's wallet. The suspect was last seen, walking away with the victim's wallet, west on 300 Market Street. An officer was flagged down a short time later by a citizen who found the victim's wallet laying in a gutter near the 600 block of 3<sup>rd</sup> Avenue. All contents were found in the wallet except for the victim's cash.*

*Suspect Description: White male, approximately 30-years-old, 6' tall, thin build, with a short full beard, wearing a black baseball cap, black shoes, dark shirt and jeans.*
