

Detectives Looking for Leads to Help Locate Suspect Wanted for a Felony Hit and Run

Up to \$1,000 Reward Offered

San Diego County Crime Stoppers and investigators from the San Diego Police Department's Traffic Investigations Unit are asking for assistance from the public to help locate a suspect wanted for a felony hit and run. The suspect has been identified as Oscar Solis Jr.

Executive Director Sally Cox (619) 275-8240 Detectives said on February 28th, 2011, Solis crashed his vehicle into a tree on 2400 Ingraham Street. Solis' passenger was severely injured in the accident. The driver door would not open so Solis opened the passenger door, pushed the female passenger out the door, and crawled over her body to get out of the car. Solis ran from the scene and flagged down a cab to get away. He later called the police to say he was car jacked. Further investigation has revealed that Solis was driving while intoxicated.

A warrant has been issued for Solis for Felony DUI and Felony Hit-and-Run. His family refuses to cooperate with the police and may be hiding him. His parents live in San Jose, Ca and his brother lives in Highland, CA.

Oscar Solis Jr. is a 24 year old (01/17/1987) White male, 5'10" tall, 180 lbs., brown hair and green eyes. He may shave his head and sometimes wears a mustache and goatee.
