FORMER SEXUALLY
VIOLENT PREDATOR

John Kreischer is registered as a former "Sexually Violent Predator" (SVP) sex offender with the California Department of Justice and the City of San Diego. Kreischer has recently moved to the downtown area of San Diego, and is now living at the Plaza Hotel, 1037 4th Avenue, #729. Kreischer is currently on Active GPS Parole Supervision and is subject to sex offender registration requirements. Kreischer is in compliance with his registration requirements and is **not** wanted by law enforcement at this time.

Kreischer's classification as a former SVP is based on felony convictions in 1988 for two counts of Kidnapping and Attempt to Commit Rape. In 1988, Kreischer was determined by the court to be a Sexually Violent Predator (SVP) and admitted to Atascadero State Hospital. Kreischer was released from Atascadero State Hospital in August of 2005 and now has a lifetime requirement to register as a sex offender. Kreischer's has additional convictions in 1977 for multiple counts of forcible Rape, 1981 for Assault with intent to Commit Rape and 2009 for failing to register as a Sex Offender. Kreischer has served several years in state prison for his crimes.

California Penal Code Section 290.45 PC, also know as "Megan's Law," permits law enforcement agencies to warn the community about sex offenders who frequent the area. The purpose of this notice is to allow members of the public to protect themselves and/or their children from sex offenders.

This notification is not intended to induce fear; rather it is our belief an informed community is a safer community. In order to uphold its mission of working in partnership with the community to provide the highest level of public safety, the San Diego Police Department has a proactive community notification policy. Use of this information to threaten, intimidate, or harass the subject or other persons will not be tolerated and may be result in prosecution.
