Random Bandits Robbery Series, Information Wanted

Starting on December 15, 2014, at approximately 2230 hours, with the robbery of Lincoln Tax Services located at 3944 Illinois Street, the city has experienced a robbery series that has spared to include 10 robberies with the last robbery occurring on January 5, 2015, at approximately 2150 hours, at Home Bar Liquor located at 3550 Ashford Street.

The suspects in this series have shown no consistent pattern in the type of business they target or how many suspects enter the business during the robbery. They have committed robberies with one, two and three suspects entering the victim business, sometimes armed with a handgun, knife, or combination of handgun, knife and unarmed. Their clothing has been described as monochromatic, lacking any insignias or designs. Generally dark colored hoodies or long sleeve shirts. Their demeanor has been demanding and forceful but lacking the use of vulgarity. In general the suspects have used phrases such as, "Open the register, give me the cash, where's the safe."

On four evenings the suspects did back to back robberies within a couple hours of each other. In all but one of the robberies at least two suspects enter the victim business.

No vehicle has been positively identified. However, due to proximity of the back-to-back robberies it is believed they have a vehicle.

The most targeted area has been Northern with five cases. (Four in the La Jolla area and one in the Clariemont area).

The following is the suspect's description in each case:

Case 1: (Lincoln Tax Services)

Suspect one: B/M/A, 25-30 years, 5'07"- 5'09", 140-150, Unknown facial hair or hair color, wearing a dark colored beanie (Possibly Navy blue) dark gray or black scarf (used to cover lower portion of face), dark blue or black hoodie, blue jeans, armed with a black semi auto handgun

Suspect two: B/M/A, 25-30 years, 6'-00", 170-180, mustache, black hair, Dark hoodie with the hood pulled over his head, dark pants, armed with silver semi auto handgun

Case 2: (Living Spinal)

B/M/A, 20-30, 5'11" – 6'00", 180 – 190, black baseball cap, black bandana or scarf covering his face, dark long sleeve shirt or hooded sweatshirt, dark colored pants, armed with a black semi auto handgun hood over head and cinching hood to cover a portion of his face

Case 3: (La Jolla Village Lodge)

Suspect one: B/M/A, 25-30 years, 5'07"- 5'09", 140-150, Unknown facial hair or hair color, wearing a dark colored beanie dark gray or black scarf (used to cover lower portion of face), dark blue or black hoodie, blue jeans, armed with a black semi auto handgun

Suspect two: B/M/A, 25-30 years, 6'-00", 170-180, mustache, black hair, Dark hoodie with the hood pulled over his head, dark pants, armed with silver semi auto handgun

Case 4: (The Wineding Shoe a Salon & lounge)

Suspect one: B/M/A, 25-30 years, 5'07"- 5'09", 140-150, Unknown facial hair or hair color, wearing a dark colored baseball cap, dark gray or black scarf (used to cover lower portion of face), dark blue or black hoodie, blue jeans, armed with a small knife

Suspect two: B/M/A, 25-30 years, 6'-00", 170-180, mustache, black hair, dark hoodie with the hood pulled over his head, dark pants, armed with silver semi auto handgun

Suspect three: B/M/A, 20-30, 5'11" – 6'00", 180 – 190, black baseball cap, black bandana or scarf covering his face, dark long sleeve shirt or hooded sweatshirt, dark colored pants, unarmed

Case 5: (Los 2 Pedros Taco Shop)

Suspect one: B/M/A, 20-35 years, 5'07"- 5'09", 140-150, Unknown facial hair or hair color, wearing a dark colored baseball cap, dark gray or black scarf (used to cover lower portion of face), dark blue or black hoodie, blue jeans, unarmed

Suspect two: B/M/A, 25-30 years, 6'-00", 170-180, mustache, black hair, dark hoodie with the hood pulled over his head, dark pants, armed with silver semi auto handgun

Suspect three: B/M/A, 20-30, 5'11" – 6'00", 150 – 160, black baseball cap, black hair, dark hoodie with the hood pulled over his head, dark pants, armed with black semi auto handgun

Case 6: (Sands of La Jolla)

Suspect one: B/M/A, 20-30, 5'08" – 6'00", 175-220, Dark hoodie with the hood pulled over his head, dark pants, gloves, armed with silver semi auto handgun

Suspect two: B/M/A, 20-30, 5'08" – 6'00", 220 – 250, Dark hoodie, dark pants, sports gloves, no weapon

Case 7: (Subway)

Suspect one: B/M/A, 20-25, 5'08"-5'10", 150-160, Black bandana covering his face, gray hoodie, black and gray shorts, black gloves, armed with a black semi auto handgun

Suspect two: B/M/A, 20-25, 5'10"-6'00", Dark hair, dark clothing, NFD

Case 8: (*attempt pedestrian robbery of Saracia Shannahan*)

Suspect one: B/M/A, 20-25, 6'00"-6'01", thin, black and white hoodie, black handgun, NFD

Suspect two: B/M/A, 20-25, 5'08"-5'91", heavy, black hoodie and dark pants, no weapon

Case 9: (Shakeaway)

Suspect one: B/M/A, 20s, 5'11", 200, Black facemask, black hoodie, black gloves, blue jeans, tan Timberland boots, and black Glock-type semi auto handgun

Suspect two: B/M/A, 20s, 6'01", 200, Black ski mask with cut outs for eyes only, black hoodie, dark pants, armed with large black semi auto handgun.

Suspect three: was seen running away with suspect one and two, NFD

Case 10: (Home Bar Liquor)

Suspect one: B/M/A, 24-25,150-180, Black knit cap, black bandana, black zip-up hoodie sweatshirt, black pants, black gloves, armed with large black semi auto handgun

Suspect two: B/M/A, 30,160-170, Black knit hat, black bandana, black hoodie, blue jeans, no weapon seen

Suspects were armed with at least one handgun in all of the robberies.
