## **WANTED for MURDER**

### **ANTONIO JOSE ROJAS HERRERA**

**ALIASES/MONIKERS:** Antonio Jose HERRERA, Jose Antonio HERERA, Tonio, Toño.

On the evening of May 05, 1988, the victim, Jose Ramirez Castaneda and Antonio **ROJAS** were involved in a physical altercation. The following morning on May 06, at approximately 0730 hours, **ROJAS** knocked on Castaneda's residence located at 2849 K Street, in the Grant Hill community of San Diego, California. **ROJAS** was armed with a handgun and entered the residence. Castaneda was sleeping in the living room. **ROJAS** shot Castaneda once in the chest. Castaneda was transported to the hospital where he later died. **ROJAS** fled the scene in his brother's vehicle. Later that morning, **ROJAS** was detained at the US Border Patrol checkpoint in San Clemente, California. US Border Patrol agents were unaware **ROJAS** had just killed someone. They took custody of **ROJAS** for illegal entry into the United States and deported him back to Mexico. **ROJAS** is wanted for his alleged involvement in the murder.
