





WANTED for MURDER

GONZALO HERRERA MONTANEZ

ALIASES/MONIKERS: *Gonzalo HERRERA, Gonzalo MONTANEZ, Gonzalo AERRERA.*

GONZALO HERRERA MONTANEZ was the victim's, Maria Hanbury, employee and had a child with Maria Hanbury's daughter. On *March 22, 1990*, **GONZALO HERRERA MONTANEZ** battered and stabbed Maria Hanbury several times killing her at her residence located at 1804 Lonja Way in San Ysidro community of San Diego, California. Tijuana police authorities discovered the body of Maria Hanbury burned in the trunk of her burned vehicle abandoned at Ejido Buenos Aires in the community of La Presa Abelardo L. Rodriguez, Tijuana Baja CA, Mexico. **GONZALO HERRERA MONTANEZ** sustained cuts during the struggle. **GONZALO HERRERA MONTANEZ** fled to Tijuana, Mexico where he was treated for his injuries. **GONZALO HERRERA MONTANEZ** is wanted for his alleged involvement in the murder.
