## **WANTED for MURDER**

### **NICOLAS LLAMAS SANDOVAL**

**ALIASES/MONIKERS:** Nicolas SANDOVAL, Nicholas Llamas, Nico Sandoval Llamas, Antonio Macias Rodriguez, Rudy Castillo. "Nico," "Grifo"

On September 19, 1976, **NICOLAS LLAMAS SANDOVAL** entered his estranged girlfriend's house located in the 300 block of University Place in the Hillcrest community of San Diego. His estranged girlfriend returned to the house accompanied of her young child, a female friend, and male friend, Ambrose Soniga. They found **NICOLAS LLAMAS SANDOVAL** sitting on a couch cradling a shotgun in his lap. Mr. Soniga and the female friend walked out of the house towards their vehicle. **NICOLAS LLAMAS SANDOVAL** followed Mr. Soniga and shot him in the chest. **NICOLAS LLAMAS SANDOVAL** then beat Mr. Soniga with the butt of the shotgun. **NICOLAS LLAMAS SANDOVAL** fled the scene. Mr. Soniga was transported to the hospital where he died. **NICOLAS LLAMAS SANDOVAL** is wanted for his alleged involvement in the murder.
