





## **WANTED for MURDER**

### **SERGIO RANGEL-MEDINA**

**ALIASES/MONIKERS:** "Guaripas" Sergio MARINA, Sergio Rangel MERINO, Sergio RANGEL, Sergio MEDINA.

On October 16, 1980, **SERGIO RANGEL-MEDINA** and his companion were involved in an argument with the victim, Ruben Gonzalez, in the south alley of 3100 Greely Street in the Logan Heights community of San Diego, California. The argument escalated to a physical altercation between the three of them. **SERGIO RANGEL-MEDINA** stabbed Mr. Gonzalez. Mr. Gonzalez died at the scene. **SERGIO RANGEL-MEDINA** and his associate fled the scene. **SERGIO RANGEL-MEDINA** is wanted for his alleged involvement in the murder.
