- I. Call to Order:** The meeting was called to order at 6:05 p.m. Roll call was conducted. A quorum was established.

John Stump asked that agenda item V. A. Election of open Community Organization –At – Large representative be continued. No motion to continue the election was made by the PAC.  
M/P (12-0-1) Motion to approve agenda as changed.
- III. Minutes:** Table approval of January minutes until March 13, 2006 meeting.
- IV. Public Comment, PAC Members Comment and Staff Announcements**

**Public Comment**

Jose Lopez – Read the attached letter.

Maria Otero Gonzales – “estoy aqui hablando Español porque hay mucha gente en la comunidad que hablan Español y necesitan la informacion en Español.” Translation: I am speaking Spanish because there are many Spanish speaking residents in this community that need the information in Spanish.

Jay Powell - City Heights Community Development Corp – Informed alert on Mid-City Stations and systems and stressed importance of bridge decks as an economic development feature. As stated in M.O.U. negotiated with the State of California and City, the trolley or Bus Rapid Transit was to run in the median of the Interstate 15 and elevators and escalators would be provided and they will not be seen until the next decade unless it is brought up.

### **PAC Member Comment**

Michael Sprague – City Heights Area Planning Committee elections will be held the first Monday of March. Applications must be received by February 27<sup>th</sup>, 2006 with general rules and conditions and a map.

Astrid Cybulskis - Asked for an attendance review for the month of March.

David Taylor – Announced that the partners for Livable Space in San Diego is presenting on strategies for creating our urban environment, called “Creating the City, Love it or Leave it”. Takes place on March 15, 2006.

## **V. Administrative Matters – PAC Action**

### **A. Election of open Community Organization –At – Large representative**

John Stump requested to speak on the item but was denied by the Chair.

Staff verified four candidates qualified for the vacant Community Organization At-Large seat.

The candidates spoke in the following order:

Ahmed Hassan – Horn of Africa Community

Tony LoPresti – City Heights Community Development Corporation

Thomas Mangum – Cherokee Point Neighborhood Association

Elizabeth Tate – Florence Griffith Joyner Youth Foundation

Elizabeth Tate was declared the winner in a runoff vote.

Elizabeth Tate immediately assumed her office and took her seat on the PAC.

## **VI. Old Business – PAC Action**

### **A. Model School JPA**

Wendy Dewitt – Project Manager for San Diego model schools development group gave an update. February meeting was cancelled; next meeting is March 9, 2006 at 10:00am.

Finance subcommittee meeting is scheduled to review alternative sources to help finance potential roadway improvements, open space enhancements and a proposed child development center.

A request was made to the JPA Board that “attendance boundaries” of the Model School be distributed to the PAC.

### **B. Affordable Housing Collaborative (NOFA) Recommendation and Funding**

M/UC (15-0-0, Housing Subcommittee) Motion to not support Agency staff recommendation for extension of the NOFA program.

**VII. New Business – PAC Action**

**B. El Cajon Blvd. Pilot Village**

Rich Juarez of Urban West Development (partners with Christopher Sickles Group) gave a presentation for a proposed project for the Pilot Village site (two block site between Meade Ave. and El Cajon Blvd. and between 38<sup>th</sup> St. and 40<sup>th</sup> St.)

M/S/P (8-5-3, Gillette/Nelson) Motion to recommend the start of the ENA process with the proposed development team.

**A. Proposed Consultant Contract with Keyser Marston Associates**

Jim LoBue explained that no new contract was needed with KMA as there is still funding left in their current contract. The Agency staff asked the PAC to participate on a “SR-15 Corridor Steering Committee” to advise the Agency in actions related to developer recruitment for redevelopment projects in the area. PAC members discussed the need to also pursue new development in other location in the Project Area. It was agreed that the steering committee would also look into these opportunities.

Alfred Ilginis and Richard DeHoyos volunteered to sit on the committee.

**C. Safe Routes to Schools**

Andrea Groves of the CHCDC gave a presentation on Safe Routes to School funding and requested the PAC to recommend \$537,737 in funding for the project.

M/S/P (11-5-0, Gillette/Taylor) Motion to support the project in concept only with no funding.

**D. Request from the San Diego Police Department**

Captain Bob Kanaski of the San Diego Police Department gave a presentation on the proposed use of surveillance cameras on El Cajon Blvd. and University Ave. He stated that he may return later to request funding assistance.

M/S/P (13-1-2, Gingles/Ilginis) Motion to support the project in concept.

**A. Chair’s Report**

**B. Housing Subcommittee**

**1. Face Lift Program – Supplemental Agenda Item**

M/P (13-3-0, Housing Subcommittee) Motion to fund the FaceLift Program with \$50,000 of 20% Low-Mod Housing funds in fiscal year 2006-2007.

**C. Budget Subcommittee**

Joe Sciarretta passed out a report on City Heights redevelopment budget information.

**RE: 3% Hispanic and Set-aside by right, At-large Seats, Reflecting Area Population.**

Honorable Chairwoman and Members of this Committee:

Tonight, I am here before you divested of all public office, appointments and associations and only as a simple interested citizen.

As interested citizen, I will supply SANDAG information to the Secretary of State and to the City Attorney to the fact that this **precinct** is more than 3% Hispanic, in fact 53% [Census 2000]. Therefore, meeting notices, ballots and election materials needs to be distributed in Spanish also,

Pursuant to *California Elections Code [CEC] §14201 (a) (f)* inclusive.

Also I will request a City Attorney's Office **Legal Opinion** on the following matters:


1. A substantial number of **LOW/Moderate**-income persons need to be members of this committee,  
Pursuant to *California Redevelopment Law [CRL] (Health and Welfare Code [HWC])* § 33385 (a) (1).
  - A. The Project Area Committee shall only include, when applicable, elected representatives of residential owner occupants, residential tenants, business owners and existing organizations (religious institutions and other nonprofit organizations inclusive) within the project area. On this issue, the set-aside by right, at-large seats for the *City Heights Area Planning Committee [CHAPC]* and the *City Heights Town Council [CHTC]* come strongly to mind, just to mention a few.
  - B. On the matters of the **CHAPC** and **CHTC** set-aside by right, at-large seats:
    - a. The **CHAPC** is a sanctioned committee of a legislative body, the City Council,  
[CRL] HWC § 33385 (g)
    - b. The **CHTC** is a 501(c)(3) nonprofit organization set **prejudicially** apart from any other. To equalize the field, its representative should be appointed by the organization and she or he shall run for election like any other candidate in the electoral process of this precinct, pursuant to [CRL] HWC § 33385 (a) to (j); 33385.3 (a) (b); 33385.5; 33386; 33387 and 33388 (a) (b) inclusive.
2. To the best of my knowledge, set-aside by right, at-large seats are illegal, at least since 1969 [Allen V. State Board of Elections]. This distribution of seats dilute minority votes, voting rights and stack the dominance of the prevalent governing group (voting as a block) [Thornburg V. Gingles, 1986] **against** prevalent minorities reflecting area population and [disenfranchised from the governing group] interested individuals.

3. Cross-reference seats greatly compromise the **INDEPENDENT** [*free thinking*] decision making of this body, and they shall be subjected to the electoral process of this precinct also [*USA V. Blaine County, April 7, 2004*], **42 United States Code [USC] § 1973, 28 USC § 1291** and the **Voting Rights Act of 1965 § 2 & 12 (d)** inclusive.

In parting, with all due respect, I request to the Honorable Chairwoman, two things:

- A. To have the duly elected Secretary of this committee enter and reflect my comments into the public records of this committee and to attach this letter and all submitted attachments to the minutes of this meeting.
- B. To give direction to the Redevelopment Agency Staff to compile a cross-reference list of occupied seats from the members of this committee, who also seat at the **CHAPC, CHTC** and any other set-aside by right, at-large seats, within thirty [*30*] days of this notice. Such list should be delivered to this committee's Chair with a copy to my place of residence, Thank You.


