OUTCALL NUDE ENTERTAINMENT BUSINESS



San Diego Municipal Code, Section 33.0101(c), states you must have a valid police permit to operate a business designated as police regulated. You are responsible for being familiar with and complying with the rules and regulations related to Nude Entertainment Businesses or Outcall Nude Entertainment. Copies of the Outcall Nude Entertainment Business Ordinance and General Divisions Ordinances for police regulated activities may be obtained from the City Clerk's office located at 202 C Street, 2nd Floor, Telephone # (619) 533-4000 or via the City's website: https://www.sandiego.gov/city-clerk/officialdocs/municipal-code

Note: Regulation and enforcement will continue to be performed by SDPD.

YOU MUST PROVIDE ALL OF THE FOLLOWING WHEN APPLYING FOR THE ABOVE MENTIONED POLICE PERMIT INCOMPLETE APPLICATION PACKETS WILL NOT BE ACCEPTED

- **NOTE:** The granting of a police permit does not relieve the applicant from obtaining all appropriate approvals required by the City of San Diego, State, or Federal law. The granting of a permit does not relieve a permittee from the permittee's obligation to comply with all applicable Local, State, and Federal laws, including those related to building, zoning, fire, and other public safety regulations. The granting of a police permit does not vest any development rights in the property or business (SDMC 33.0309). In order to legally operate your business and to establish that your business location is suitable, it is **strongly recommended** that you first obtain the following:
 - o <u>ZONING APPROVAL</u> This can be obtained from the City of San Diego Development Services, 1222 First Avenue, 3rd Floor, San Diego, CA 92101, Telephone No.: (619) 446-5000.
- <u>POLICE PERMIT APPLICATION</u> Fill out the application completely. Only one of the owner/officers must complete the Police Permit Application. A criminal records check will be made on the applicant. A 30-day investigation period begins at the time the complete application is submitted.
- <u>BUSINESS ADDENDUM</u> Each additional corporate officer or partner is deemed an applicant and must complete a Business Addendum application. An applicant who is a corporation or partnership shall designate one of its officers or general partners to act as its responsible managing officer. The responsible managing officer may complete, sign and submit all applications on behalf of the corporate officers and partners. A criminal records check will be made on each applicant. A 30-day investigation period begins at the time the complete application package is submitted.
- <u>STATEMENT OF UNDERSTANDING</u> You must submit a signed statement of understanding with your application.
- <u>LIVE SCAN FINGERPRINTS</u> **Required** for all new applicants. The San Diego Municipal Code states Fingerprints must be taken by a Governmental Agency. See attached list of locations. Fill out the attached "Request for Live Scan Service" form and bring it with you to a Live Scan agency. Return your completed application to the Office of the City Treasurer so your application can be processed. **The completed** "**Request for Live Scan Service**" form is valid for only thirty (30) days from the date your fingerprints were taken. After thirty (30) days you will be required to re-do your Live Scan fingerprints.
- <u>BUSINESS TAX CERTIFICATE</u> City of San Diego Business Tax Certificates can be obtained from the City Treasurer's Office located at 1200 Third Avenue, 1st Floor, San Diego, CA 92101, Telephone No.: (619) 615-1500.
- <u>CORP ARTICLES, LIMITED PARTNERSHIP DOCS, OR FICTITIOUS BUSINESS NAME STATEMENT</u> Applicable documentation as filed with State of California and/or County of San Diego.
 - <u>LEASE OR RENTAL AGREEMENT</u> A copy of your lease or rental agreement and amendments for the property where the business is to be conducted.
- <u>IDENTIFICATION</u> A valid Government issued photo identification card (i.e. driver's license or military ID).

In addition to the annual PD Regulatory fee, all new and renewal permits are assessed a non-refundable Application Fee*. The application fee consists of a \$24 investigative fee (background review) per owner/officer and a \$63 administrative fee (\$59 at the time of renewal).

OUTCALL NUDE ENTERTAINER Statement Of Understanding Operating Requirements And Regulations

PLEASE READ CAREFULLY: It is unlawful to work as an outcall nude entertainer without a police permit. The outcall nude entertainer permit that is being issued to you is not a license to conduct an outcall nude entertainment business. To legally work as an outcall nude entertainer, you must be employed by someone who possesses an outcall nude entertainment business permit. The permit is valid for a period of one (1) year from the date of issuance. An outcall nude entertainer may perform in a temporary status with a permit during the thirty (30) day investigation period or until their application for a permit is denied. It is your responsibility to renew the permit before the expiration date. No renewal notice will be mailed to you.

Copies of the <u>Outcall Nude Entertainment Business</u> Ordinance and General Divisions Ordinances for police regulated activities may be obtained from the City Clerk's office located at 202 C Street, 2nd Floor, San Deigo, CA, Telephone No.: (619) 533-4000 or via the City's website: <u>www.sannet.gov/</u> (Department, City Clerk, Documents, Municipal Code), <u>SDMC Chapter 3</u>, <u>Article 3</u>, <u>Divisions 1-5</u>, and <u>28</u>. The following summarized sections are from the San Diego Municipal Code unless otherwise indicated:

PLEASE INITIAL EACH LINE STATING YOU HAVE READ AND UNDERSTOOD THE OPERATING REQUIREMENTS AND REGULATIONS:

- <u>33.2802 Outcall Nude Entertainer</u>: Includes strippers for bachelor and bachelorette parties, lingerie models, and other similar entertainers. It includes any person who entertains while nude or whose performance is distinguished or characterized by an emphasis upon the display of specified anatomical areas or specified sexual activities.
- "Outcall nude entertainment business" means any person who, for a fee, commission, hire, reward or profit, furnishes or offers to furnish an outcall nude entertainer, as defined in this section, for any individual or group at a location other than a fixed business establishment licensed to provide nude entertainment. It includes businesses that provide outcall nude entertainers such as lingerie models and strippers.
- "Nude" means being devoid of an opaque covering which covers the genitals, pubic hair, buttocks, perineum, anus or anal region of any person, or any portion of the female breast at or below the areola.
- "Specified anatomical areas" means and includes less than completely and opaquely covered human genitals, pubic region, buttocks, anus, female breasts below a point immediately above the top of the areola, or human male genitals in a discernible turgid state, even if completely and opaquely covered.
- "Specified sexual activities" means and includes the fondling or other touching of human genitals, pubic region, buttocks, anus or female breasts; sex acts, normal or perverted, actual or simulated, including intercourse, oral copulation, or sodomy; masturbation, actual or simulated; excretory functions as part of or in connection with any of the activities set forth above.
- <u>33.2803(a-d)</u> <u>Permits Required</u>: In addition to their own police permit, every outcall nude entertainer must carry a copy of the outcall nude entertainment business permit with them when working as an outcall nude entertainer.

Rules and Regulations 33.2813(a) - Six Foot Rule: While nude, an outcall nude entertainer shall not be within six feet of a patron. 33.2813(b) - No Touching During Performances: An outcall nude entertainer shall not intentionally touch any patron during any performance, or allow any patron to intentionally touch the outcall nude entertainer whether nude or not. 33.2813(c) - Unlawful To Provide Massage: When acting as an outcall nude entertainer, it is unlawful for any person to provide massage services. If the outcall nude entertainer also holds a police permit as a massage therapist or holistic health practitioner, he or she may not provide massage services to a patron immediately before or after providing outcall nude entertainment services. 33.2811 - Advertising Requirements: Each outcall nude entertainer or outcall nude entertainment business shall include the number of its applicable police permit in any advertisement of services appearing in any newspaper, telephone directory, other printed advertising medium, or electronic media. 33.2808(e) - Operating Hours: It is unlawful for any outcall nude entertainer to provide services between the hours of 2:00 a.m. and 6:00 a.m. 33.0312 - Change of Employment: Must notify the Chief of Police (Police Permits and Licensing) within fifteen (15) calendar days of changing employers. 311.6 -- California Penal Code: It is a misdemeanor to knowingly engage in, or participate in, obscene live conduct. **647(b)** -- California Penal Code: It is a misdemeanor to solicit or agree to engage in any act of prostitution. Prostitution includes any lewd act between persons for money or other consideration. (In addition to agreeing to a sex act, encouraging a patron to masturbate while you perform could be considered a violation of this section.) I have read and understand the operating requirements and regulations summarized above. I understand it is my responsibility to be familiar with all laws and regulations governing this activity. I understand that my permit to act as an outcall nude entertainer may be suspended or revoked for violation of the laws and regulations governing outcall nude entertainment. I understand that I may schedule an interview with a Permits and Licensing Police Code Compliance Officer if I have any questions regarding these regulations or my employment in a police regulated occupation.
