## Save Water NO We face unprecedented water supply challenges.

Severe drought and court-ordered pumping restrictions have caused our water supply to drop to historic low levels. The photos of Lake Oroville, above, show a 35% drop in its water level since 2005. Metropolitan Water District of Southern California, the largest supplier of San Diego County's water, could deplete its non-emergency storage reserves by the end of 2009. Water deliveries to many farmers have been cut by 30 percent. Water rationing for homes and businesses could be imposed.

You can help. The San Diego County Water Authority and your local water agency urge you to take immediate action to reduce water use now, especially outdoors. Significant savings can be achieved by:

- Watering no more than three days a week, cutting back during cool weather.
- Shortening your watering times by 1-2 minutes.
- Fixing leaks and broken sprinkler heads.
- Adjusting sprinklers to avoid spraying paved areas.


### High-Efficiency Clothes Washer Rebates — up to \$185
