

2015-2016 REPORTABLE CAMPAIGN COMMITTEES FOR QUARTERLY DISCLOSURE REPORTS – SCHEDULES C, D, and E

Lobbying Firms and Organization Lobbyists must disclose their fundraising efforts (\$2,000 or more) and contributions (\$100 or more) and those made by their owners, compensated officers, lobbyists, and sponsored committees to every committee: (1) controlled by a City candidate or (2) primarily formed to support or oppose a City candidate. In other words, when completing their 2015 and 2016 quarterly reports, lobbying entities must report fundraising efforts and contributions benefiting the following committees:
