APPROVAL OF THE MINUTES of January 20, 2022

RANGER REPORTS

Brandon Schroeder shared that there is an uptick in school visits to the Ranch House. Grant funded project with Urban Corps to work on trails in May, focusing on the single-track trails perhaps getting debris out that is impacting waterflow. Looking at tenting the ranch house for termites in the next couple of months. The historical marker on the monument will be replaced due to updated information, funded by the Park Society. Trail counters were placed as one of 10 parks. Hoping to expand the counters, perhaps to include equestrian counters. This is a pilot project, the county has to report monthly visitation numbers, attendance numbers don't break down by usership. They are also working to close social trails and revegetate bare areas. (Weekend 930 average per day second busiest park of the 10)

City Sr. Ranger Gina Washington reported on the success of the new bumper signs in the Preserve on the single-track. The first kiosk was refurbished and they are in talks with a potential Eagle Scout project for one of the kiosk replacements.

CORRESPONDENCE - None

<u>PUBLIC COMMUNICATIONS</u> – Anne Fege got a Friends of LPCP Bylaw revision proposal and she shared that the changes seem to legitimize a smaller group though it has an immense goal. Erik Basil shared that it isn't really appropriate for the CAC to discuss how they run their organization. Braund shared that the only thing discussed at the Friends meeting was changing votes from members to board members.

ACTION ITEMS

101. Letter to County Supervisor and San Diego City Councilmembers on the LPCP Task Force, their historic role, what the CAC is doing, and to encourage them to become active again.

Frank received good comments for revision on the draft letter. He shared the letter with the group. The Task Force was established in 1977 subsequently the Task Force appointed the first Citizens' Advisory Committee.

There was a discussion about how to convey the importance of the CAC and what is accomplished at the meetings. Additionally, it was mentioned to emphasize the difference between park and preserve. Several other edits were made. It was expressed that the view in the Human Use section of the letter as originally drafted was specifically anti-bike. A reasonable discussion was had that resulted in a substantial change to reflect the real issue of increased usership of the limited resources in the Preserve.

201. <u>Brief Update on the County's Bridge and Amphitheater Project</u> - Jen Spence shared that they have the task order and contractor on board. First community meeting will be in April/May. 202. <u>Update on Outreach Activities in the Preserve</u> – great kick off on the first kiosk refurbishment. Looking forward to continuing the project.

ORGANIZATION REPORTS

<u>Friends of LPCP</u> – Mr. Braund shared that the Friends volunteer performed GSOB surveys, the report is not very good. The canopy of the trees is declining, not sure if it is from GSOB or drought. The largest tree in the canyon at Carson's Crossing is dead. Spraying will occur in May but is yet to be scheduled. The Friends agreed to accept the money from the POPs settlement with Cistera; in the neighborhood of \$500,000 and will be under the control of POPs.

<u>San Diego Mountain Biking Association</u> – Mr. Bartelt shared that the bell stations are being regularly replenished. Work on Darkwood Connector trail has begun. He also shared that SDMBA is implementing a Trail Ambassador program to assist Preserve staff with eyes in the field, similar to the original Volunteer Patrol.

<u>COMMUNITY PLANNING GROUPS</u> Mira Mesa Community Planning Group – no report

<u>Carmel Valley Community Planning Group</u> – Alternate quit recently, there is a need for someone active in the canyon that lives in Carmel Valley to be the alternate to the CAC.

<u>Del Mar Mesa Community Planning Group</u> – The DMM garden club is celebrating Earth Day on April 3rd from 2-5 pm at Elizabeth Rabbitt Park as part of community outreach. You are all invited to stop by.

Ms. Parikh shared that Councilmember LaCava seems to be listening to the concern about proposed changes to Community Groups.

<u>Rancho Peñasquitos Community Planning Group</u> – Mr. Heinz piggy-backed on what Ms. Parikh said. There seems to be softening, the council vote was postponed indefinitely to rework the entire proposal. Will the community groups have any teeth when it's all done remains to be seen.
