 City Council Redistricting: Ryan Clumpner presented an overview of the current district boundaries and population including possible combined redistricting of Clairemont and Linda Vista.

Board members asked questions about the population of Clairemont, timelines for the public hearing, boundaries of proposed district

Motion #1 - Motion by V. Ochoa to recommend having the entirety of Linda Vista in one council district rather than being split as it currently is. Second by M. Castro. Questions and discussion by board members was held. Roll call vote of the members present: 10-0-0, motion carried.

Motion #2 – Motion by F. Senoski to support Linda Vista be joined in a council district with all of Clairmont. Second by K. Heinle. Questions and discussion by board members was held. Roll call vote of the members present: 9-1-0, motion carried.

2. Auxiliary Dwelling Units: Newell Booth, David Moty, Bob Jaynes and Danna Givot representing Neighbors For A Better San Diego, presented an overview of the proposal to amend San Diego's Auxiliary Dwelling Unit ordinance. The amendment supports San Diego ADU code complying with similar ADU codes used by other CA cities.
