Statement from from public on behalf of Kate Callen

This message is not intended for Jeff Ryan personally. He has a tough job serving as the Planning Department's messenger to North Park. Tonight, I am asking him to bring two messages back to his superiors:

First: Do not threaten us with any kind of action unless you are prepared to take that action. Anything else is schoolyard bullying.

Second: If you decide to move against us for failing to comply with a sudden edict, like insisting (with no explanation) that the Brown Act requires Board members to disclose their physical locations during Zoom meetings, remember that North Park has a long history of taking legal action. We know how to fight.

Your City Hall bureaucracy made a smooth transition to hybrid meetings because it has ample resources: dedicated meeting spaces, advanced technology, paid staff. We have none of that. We received NO guidance or help from City Hall with the switch to hybrid meetings. But then, we rarely get support from the City. We can't even get our expenses reimbursed.

When all-volunteer planning groups achieve progress toward our goal of inclusivity, City Hall takes no notice. North Park is the only group that has successfully conducted on-line voting. Our elections are now more accessible, and voter turnout has increased. Has anyone from Planning said, "Great job, maybe other groups can learn from you"? No. But if we struggle with a requirement or seem to make a misstep, down comes the hammer.

A final message for our Council rep, Stephen Whitburn: When you appeared at our October meeting, you expressed strong support for NPPC and for all planning groups. Please walk your talk by asking City Hall to give planning groups the help we need to comply with its directives.
