Budget season is upon us.

Mayor Kevin Faulconer proposed the Fiscal Year 2018 budget to the City Council on April 17. You can read the full details at www.sandiego.gov/fm/ proposed.

While we have an \$81 million budget gap, this budget does a good job at protecting the services we desperately need. However, there is some room for improvement. I want to assure you that my staff and I are taking a close look at the budget to ensure our budget not only protects our neighborhood services, but funds our efforts on affordable housing, infrastructure, and homeless services.

In an effort to gather your input, our office will host a Budget Town Hall with Independent Budget Analyst, Andrea Tevlin, on May 18th at Hoover High School from 6 p.m. to 8 p.m.

Join us as we discuss what the proposed budget means for our neighborhoods and provide your

input on the City's budget priorities.

The City Council will also hold budget hearings, with presentations from each department, beginning May 3rd to May 9th at City Hall from 9 a.m. to 5 p.m.
