- 6.4 square miles, 77,000 residents in the Promise Zone
- Infrastructure of community-based organizations, bringing everyone together to work collectively
- 6 goal areas, 6 working groups

 - o Collectively working around priority of safety: To look at activities identified in the designation
 - \circ $\,$ Create lasting and sustainable change over the next 10 years

Review Safety Goals and Activities

- Create a priority of safety, reduce crime hotspot, engage residents, revitalize infrastructure
- Part 1 Crimes
 - 85 shootings within the Southeastern division
 - Basic assault on another (last year particularly busy, this year not as busy)
 - Street robberies crime of opportunity
 - North Gate Market
 - 3500 National
 - Euclid and Market
- Community Policing Model
- ACES childhood services, informed care
- Next Door as a tool that can be used for reporting/updates/notification
- SDPD already doing a lot of what's on the list (walking up, etc.)
 - o Southeastern division has the least amount of complaints about law enforcement
 - Shot Spotter program in this division (ONE shot spotter throughout east as substation, west as Euclid, Logan on south, market in the North)
 - 4700 Logan, male-female shooting, able to respond quickly

- 2-5 activations per week (not as much as they though)
- Solved one sheriff homicide through use of shot spotter
- Able to recover AK-40 rounds
- Activation leads to some kind of follow-up (knocking on doors)
- This year has had considerably fewer shootings than last year (17 to date, 85 total last year)
- National night out (like light the night) with Jacob's Center, lowriders ride, career outreach fair
- No over-policing effect

- Culture shift, not as cool as it was to be in a gang
- Need to build capacity of community to not fear retaliation of reporting a crime
 - People don't want to talk
 - Need to make people feel safe, feel connected to law enforcement
 - System fear within a community due to the past history and lack of confidence in being assured that once they come forth that they won't get retaliatory response
 - o Every single contact that a police officer has with someone is opportunity to build relationship
 - Every squad has to dedicate 1 hour every week to connecting with the community
- Teach neighbors emergency healthcare community-base
 - shooting immediate care
- Need to create community ownership pride in the community to improve
 - Community organizations to come back into focus the peoples' community (responsibility for what takes place in the community)
- Room to add something/some activity for community growth investment
 - Where does trust start? Of community, of neighbor, of other
 - Infrastructure is a symbol of value in the community
 - o Community forum/input, valuing community voice, collective memory and expertise, LISTENING
- Get churches involved in values, schools in education
- Tasha Williams is attending meeting up in Fresno with law enforcement
- Who else do we need here to accomplish these goals?
 - City, DoD community plan, active transportation groups, street lighting, etc.
 - o Transportation/Storm water
 - Planning
 - o Circulate
 - Need a positive affinity group bring community together, in addition to preventative/problem-addressing groups (some kind of announcement/app to broadcast these kind of community events)
 - Parks as community space used consistently
 - o Low Riders
- Public perception that undermines trust
 - Relates to economic development improvement

- What do we have to put in and what do we expect to get out
- Visual representation that will show our process will probably start next month
- Acknowledge reality and what people are already working on, use that to establish a baseline
 - Put thought into things that are already happening in terms of how do they directly impact the activities and what isn't already covered

 - o Number of high school graduates Gompers, Lincoln, Ferrel
 - o 222 grads at Lincoln, only 113 completed A-G requirements

- 49 African American seniors, 30 completed A-G, 61.2% •
- 146, 46%
- 709 African American seniors, 51% A-G 0
- o Lincoln above average
- San Diego Unified School District
 - 808 applications from PZ zip codes
 633 CSU eligible

 - Only 289 admitted (while still CSU eligible, have to pass test score too)

 - Still going to UC Riverside, community college
 Not making grades = getting into safety concerns
