SUBJECT: Appointments to the Youth Commission

In July, I announced the return of the Youth Commission. I am now pleased to appoint Perla Alcazar Pulido, Devin Green, Elisa Delle Monache, Charlie Nieto, Avery Wulf, Beret Dernbach, Daxton Gutekunst, Chantel Perry, Diego Soto Lopez, Anusha Kadiyala, Kenan Pala, Maria Fernanda Freaner, Andrew Levikow, Jesus Martin Gallegos-Munoz, Oscar Rendon, Fartun Adan, and Evelyn Gomez to the Youth Commission. I am appointing each to two-year terms expiring July 1, 2022.

#### **Mayor**

Ms. Pulido is currently a senior at Gompers Preparatory Academy.
