Staff recommendation: To support the Parks and Recreation Department guideline regarding slacklining activities in City of San Diego Parks dated February 6, 2013 from Stacey LoMedico, Department Director, which prohibits slacklining at Mission Bay Park, citing SD Muni Code. Refer proponents to use other parks within park system that allow slacklining.

202: Curfew Implementation at Fanuel Street Park – The Pacific Beach Town Council is seeking a vote of recommendation from the Mission Bay Park Committee for the implementation of a nighttime curfew of 10:00 p.m. to 5:00 a.m. at Fanuel Street Park. Presented by Brian White, President, Pacific Beach Town Council and Marcella Teran, Neighborhood Watch Coordinator

Staff Recommendation: To remain neutral in supporting a nighttime curfew at Fanuel Street Park. Noting that imposing any type of curfew at the park will require an amendment to SD Municipal Code and San Diego City Council approval as well as approval from California Coastal Commission due to limitations of coastal access.
