## Mission Bay Fest - September 7th, 2019

### Alcohol Management Plan

The Event will be open to the public.

In order to delineate the event area 6 foot high panel fencing provided by Diamond Services will stretch across the front of the event. Alcohol beverages shall be consumed in this designated area, commonly known as a beer garden.

The fenced area will have two ten foot wide openings, one for the entrance and one for the exit and the number of guests that will be inside at any given time will not exceed the San Diego Fire Department's estimated capacity.

Guests will not be permitted to bring their own alcoholic beverages into the fenced area. Alcoholic beverages will be sold.

Guests will be informed that they are not permitted to consume alcoholic beverages outside the fenced area.

Minors will not be allowed in the fenced area.

Beer garden hours of operation will comply with the noon - 9pm hours listed on the Reservation of Space and Park Permit.
