301. 2020 Fall Classic Rowing Regatta – Event to be held Sunday, November 15, 2020 at Crown Point Shores from 6:00 a.m. to 12:00 noon with load-in beginning Friday, November 13. Rowing race on Mission Bay with 450 boats and athletes ranging from High School, College to Adults (14–80 yrs.). Estimated participation is 1000 with another 1000 spectators. No road closures and no amplified music or PA system. This year they would like to request approval to sell merchandise and food and charge for "paid" parking in the three Crown Point parking lots.

Staff Recommendation: To recommend approving event as stated above <u>except for</u> **paid parking**. All parking will remain as first come first serve and free of charge. Permit will only be valid when all lessees are notified by organizer. Notification list will be sent to organizer if event gets approval.

Thrive Half Marathon and 5K – Event to be held Sunday, October 4, 2020 from 6:00 a.m. to 12:00 noon at Ski Beach. 2000 participants expected with another 300 spectators. 5K route starts and ends at Ski Beach with post-race festival. PA system starting at 6:00 a.m. with amplified music (live band) proposed starting at 7:45 a.m. Ski Beach parking lot closure 6:00 a.m. to 3:00 p.m. with load in beginning October 3. No alcohol.

Staff Recommendation: To recommend approving event as stated above except for:

1) Complete Ski Beach parking lot closure. Only parking lot areas used as a venue can be closed to parking. No reserved or paid parking allowed; and 2) Sounds checks for live band performance cannot start until 8:00 a.m. All available parking will remain as first come first serve and free of charge. Permit will only be valid when all lessees are notified by organizer. Notification list will be sent to organizer if event gets approval.

303. Average Joe 5K – New event to be held Saturday, February 22, 2020 from 8:00 a.m. to 9:30 a.m. at Crown Point Shores with approximately 250 participants. PA system for awards and music. No road or parking lot closures and no alcohol.
