101. Walk and Roll 5K – Event to be held on Saturday, October 3, 2020 passing through Playa Pacifica from 7:00 a.m. to 11:30 a.m. Estimated participation is 150 with 100 spectators. 5K route starts at DeAnza Cove with post-race gathering. PA system for announcements and music, no alcohol or road closures.

Staff Recommendation: To recommend approving event as stated above.

Notification list will be sent to organizer if event gets approval.

102. Buddy Bowl Charity Flag Football Tournament – Event to be held November 28, 2020 from 9:00 a.m. to 1:30 p.m. at Fiesta Island OTL Fields. Estimated attendance is 200 participants with 50 spectators. No alcohol, PA system or road closures.

Staff Recommendation: To recommend approving event as stated above.

Notification list will be sent to organizer if event gets approval.

201. Curfew Implementation at Mission Bay (Bob McAvoy) Youth Fields located at 2639 Grand Ave. – The Pacific Beach Town Council is seeking a vote of recommendation from the Mission Bay Park Committee for the implementation of a nighttime curfew of 11:00 p.m. to 6:00 a.m. at the Mission Bay (Bob McAvoy) Youth Fields due to crime and unsafe conditions. Presented by Brian White, President, Pacific Beach Town Council

Staff Recommendation: To remain neutral in supporting a nighttime curfew at Mission Bay (Bob McAvoy) Youth Fields. Noting that imposing any type of curfew at the park will require an amendment to SD Municipal Code.

Special Events (Special Events that require road or plaza closures or will potentially impact park and/or institution operation, are brought to the Committee for a formal recommendation. They can be moved to Consent by action of the Committee.)

301. Girls on the Run San Diego 5K – Event to be held Saturday, May 9, 2020 from 7:30 a.m. to 11:00 a.m. at DeAnza Cove. Estimated attendance is 1800 participants with 600 spectators. Road Closures include De Anza Road, North Mission Bay Drive and portions of East Mission Bay Drive and parking lot closures at DeAnza West and East as well as lots along Playa Pacifica. PA system for announcements and music. No alcohol.

Staff Recommendation: To recommend approving event as stated above except for: 1) Complete DeAnza parking lot closures. Only parking lot areas used as a venue can be closed to parking. No reserved or paid parking allowed; and 2) Sounds checks for live band performance cannot start until 8:00 a.m. All available parking will remain as first come first serve and free of charge. Permit will only be valid when all lessees are notified by organizer. Notification list will be sent to organizer if event gets approval.

302. Ballast Point Beach & Brews 5K Fundraiser – Event to be held on September 20, 2020 from 7:30 a.m. to 12:00 noon at Bonita Cove. Estimated attendance is 700 participants with 300 spectators. PA system for announcements and amplified music. There will be alcohol sales/service. No road or parking lot closures. Route will remain on sidewalks except for crossing South Mission Beach turf and Bonita Cove turf areas. There will be a need for traffic control in five locations crossing Mission Blvd and entering parking lots along Mission Blvd. and West Mission Bay Drive.

Staff Recommendation: To recommend approving event as stated above except for traveling across turf at South Mission Beach. A shuttle/parking plan will be required. Sounds checks for amplified music cannot start until after 8:00 a.m. All available parking will remain as first come first serve and free of charge. Permit will only be valid when all lessees are notified by organizer. Notification list will be sent to organizer if event gets approval.

303. Spring into Wellness Family Fair – Event to be held on April 18, 2020 from 9:00 a.m. to 3:30 p.m. at Ski Beach. Estimated attendance is 1000 participants with vendor sales. No road or parking lot closures. PA system for announcements only, no amplified music. No Alcohol.

Staff Recommendation: To recommend approving event as stated above with added traffic and parking plan. Permit will only be valid when all lessees are notified by organizer. Notification list will be sent to organizer if event gets approval.
