Bomb Fest 2022 Car Show – Request approval to hold classic car show at Crown Point Shores Parking Lot on Saturday, October 8, 2022 from 9:30 a.m. to 5:00 p.m. load in begins at 4:00 a.m. Includes entire middle lot closure and music DJ with estimated attendance of 1300 people throughout the day. No alcohol or road closures. No shuttle or trash plan provided.

Staff Recommendation: Based on issues related to this event in previous years, staff recommends approving this event for 2022 only with the following requirements. An off-site shuttle plan is required along with Park Ranger staffing at the event organizers expense. North and South Crown Point lots will remain open for public parking. Only show vehicles, DJ stand, restrooms, dumpsters, first aid station, food trucks and vendors will be allowed in the Middle lot. No vehicles allowed on turf at any time. No alcohol, smoking, dogs or glass containers allowed. A Citywide Special Event Permit is required with added traffic control and trash/recycling plan. The 2022 event will be evaluated by staff before approving for future years.
