101. **Chief Petty Officer Heritage Day** – Request approval to hold a fundraising/networking/mentorship event for newly selected Chief Petty Officers on Friday, September 9, 2022 at Ski Beach from 7:30 a.m. to 3:00 p.m. with 3000 estimated participants, and PA system. No alcohol or road/ parking lot closures. Diane McQueen-Gipson, Secretary, Enlisted Leadership Foundation

Staff Recommendation: To recommend approving event as stated above.  
Permit will only be valid when all lessees are notified by organizer.  
Notification list will be sent to organizer if event gets approval.

102. Parkrun San Diego – Request to hold 5K run/walk events each Saturday morning (on-going), starting, January 15, 2022. Events start at 9:00 a.m. and end by 10:30 a.m. An estimated 45 participants will start and finish at South Shores Park. No road closures, no alcohol or P.A. system. Registration is free, managed by volunteers.

Staff Recommendation: To recommend approving event as stated above.  
Permit will only be valid when all lessees are notified by organizer.  
Notification list will be sent to organizer if event gets approval

201. Request approval for Mission Bay Park Committee to write a letter to local enforcement agencies regarding Park Safety at Mission Bay Park – Marshall Anderson

**Special Events** (Special Events that require road or plaza closures or will potentially impact park and/or institution operation, are brought to the Committee for a formal recommendation. They can be moved to Consent by action of the Committee.

301. Latin Music Festival – Request support for a 2-day Latin Music Festival proposed at South Shores Park (next to Sea World) on Saturday, May 14, 2022 and Sunday, May 15, 2022 with 15,000 attendees featuring live music entertainment, alcohol sales, merchandise and food vendors, mechanical rides and paid parking. Full parking lot closure with amplified sound production until 11:00 p.m. Saturday and 10:00 p.m. Sunday. Load in will occur starting Tuesday, May 10, 2022. Load out 8:00 p.m. Tuesday, May 17, 2022.

Staff Recommendation: Based on estimated attendance, this is a discretionary permit request. Staff recommendation is to **NOT SUPPORT** approving this proposed multi-day music event as stated above based on major public impacts to park and Least Tern breeding season which runs from April 15<sup>th</sup> to September 15<sup>th</sup>. South Shores is near a Least Tern breeding site and noise impacts from amplified music can affect breeding.

If supported by the Committee, Parks and Recreation will still have final discretion prior to permit approval. If approved, permit will only be valid when all lessees are notified by organizer. Notification list will be sent to organizer if event gets approval.

302. Country Music Festival Experience- Request support for a 2-Day Country Music Festival proposed at Crown Point Shores on Saturday, October 15, 2022 and Sunday, October 16, 2022 with estimated 20,000 attendees, featuring live

music entertainment, alcohol sales, merchandise and food vendors, mechanical rides and paid parking. Full parking lot closures (all three lots) and major road closures along Crown Point Drive with amplified sound production from 2:00p.m. to 11:00 p.m. Saturday and 1:00 p.m. to 9:00 p.m. Sunday. Load in starts Tuesday, October 11, 2022, load out ends, Tuesday, October 18, 2022 at 8:00 p.m.

Staff Recommendation: Based on estimated attendance, this is a discretionary permit request. Staff recommendation is to **NOT SUPPORT** approving this proposed multi-day music event as stated above based on major public impacts to park and surrounding residential neighborhood due to high attendance expected, parking lot closures, road closures, amplified music until 11:00 p.m. and alcohol consumption. This is not an appropriate venue for this event.

If supported by the Committee, Parks and Recreation will still have final discretion prior to permit approval. If approved, permit will only be valid when all lessees are notified by organizer. Notification list will be sent to organizer if event gets approval.
