ACTION ITEMS

Consent (These items are adopted without discussion; they can be moved to Adoption by any Committee Member.

101. Request approval for the revised Ragnar Relay SoCal 2022 event. Scheduled for Friday, April 29, 2022, utilizing Tecolote Shores and Crown Point as exchange points for the 200-mile course, with an estimated 400 participants. No PA system, no alcohol or road/parking lot closures. This is a different route and exchange points taking place at Mission Bay from previous years.

Staff Recommendation: To recommend approving this revised event as stated above. Permit will only be valid when all lessees are notified by organizer. Notification list will be sent to organizer if event gets approval.

Adoption (Each Adoption item requires individual action; they can be moved to Consent by action of the Committee.)

201. Request approval for Mission Bay Park Committee to write a letter requesting that the City of San Diego update parts of the Municipal Code (**§26.30 Park and Recreation Advisory Boards**) which impacts the functioning of the Mission Bay Park Committee. It is the Committee's position that the Muni Code should reflect actual on-going functions – Judith Munoz

202. Request support for the proposed Habitat Enhancement/Restoration in the Kendall Frost Reserve/Northern Wildlife Preserve (KFR/NWP). Presented by Cheryl L. Jenkins, Environmental Biologist III, City of San Diego, Public Utilities Department

Special Events (Special Events that require road or plaza closures or will potentially impact park and/or institution operation, are brought to the Committee for a formal recommendation. They can be moved to Consent by action of the Committee.

301. Country on the Coast- Request support and approval for a 2-Day Country Music Festival proposed at South Shores Parking Lot (Rose Marie Starns, next to Sea World) on Saturday, October 15, 2022 and Sunday, October 16, 2022 with an estimated 7500 attendees, featuring live music entertainment, alcohol sales, merchandise and food vendors. Parking lot closure with amplified sound production from 1:00 p.m. to 9:00 p.m. on Saturday and 1:00 p.m. to 8:00 p.m. on Sunday. Load in starts Tuesday, October 11, 2022, load out ends Tuesday, October 18, 2022 at 8:00 p.m. Off site shuttle plan will be used.

Staff Recommendation: Based on estimated attendance, this is a discretionary permit request. Staff recommendation is to **SUPPORT** approving this proposed multi-day music festival. However, South Shores parking lot must remain open on event days for emergency vehicles, public restroom access, RV dump and boat launch access. A limited number of pull through boat trailer parking spaces and single stall spaces must remain open as first come, first serve to the public. Staff recommends approval as a one-time event for 2022 only that will be reviewed by staff and Committee prior to extending to additional years. Parking lot closure limited to actual venue space used, no reserved/paid parking or road closures. An off-site shuttle plan must be used. Amplified music must end at 9:00 p.m. on Saturday and 8:00 p.m. on Sunday with alcohol service ending 30 minutes prior.

If supported by the Committee, Parks and Recreation will still have final discretion prior to permit approval. If approved, permit will only be valid when all lessees are notified by organizer. Notification list will be sent to organizer if event gets approval.

302. Mission Bay Festival #1 – Request support and approval for a one-day food, drink and music festival proposed for Mariner's Point and East Bonita Cove on Saturday, October 15, 2022 from 12:00 P.M. to 10:00 p.m. with 9000 attendees featuring live music entertainment, alcohol, food and merchandise sales. Partial East Bonita Cove parking lot closure as a venue with off-site shuttle plan in place. Load in 7:00 a.m. on October 13th load out by 8:00 p.m. on October 16th

Staff Recommendation: Based on estimated attendance, this is a discretionary permit request. Staff recommendation is to **SUPPORT** approving this proposed multi-day music event. However, staff will not support two major music festivals on the same date. Item 301 has a valid Reservation of Space for October 15, 2022 at South Shores Park, this item 302 does not have October 15th secured. If an alternative date can be found outside Least Tern breeding season, the summer moratorium and during any other major special events, staff approves this as a one-time event for 2022 only that will be reviewed by staff and Committee prior to extending to additional years. Parking lot closure must be limited to actual venue space used, no reserved/paid parking or road closures. An off-site shuttle plan must be used. Amplified music must end at 10:00 p.m. with alcohol service ending at 9:30 p.m.

If supported by the Committee, Parks and Recreation will still have final discretion prior to permit approval. If approved, permit will only be valid when all lessees are notified by organizer. Notification list will be sent to organizer if event gets approval.

303. Mission Bay Festival #2 – Request support and approval for a one-day food and music festival proposed for Saturday, November 12, 2022 at Fiesta Island from 12:00 p.m. to 10:00 p.m. with 15,000 to 20,000 attendees, RV parking and alcohol sales. Load in starts November 10th load out ends November 13th. Use of Sun Runner lot for off-site shuttle.

Staff Recommendation: Based on estimated attendance, this is a discretionary permit request. Staff recommendation is to **NOT SUPPORT** approving this music event as proposed based on major public impacts to park and surrounding areas due to high attendance proposed, limited access to fenced dog area, lack of detailed traffic exit plan and overnight RV parking. If organizer can decrease the number of attendees to under 10,000, eliminate overnight RV parking, provide a suitable traffic exit plan to avoid major congestion, ensure public vehicle access around the Island as well as access to the fenced dog area at all times, staff will consider supporting this as a one-time event for 2022 only, with staff and Committee review prior to approving for future years. Note: Kaiser Half Marathon is schedule for November 12, 2022.

If supported by the Committee, Parks and Recreation will still have final discretion prior to permit approval. If approved, permit will only be valid when all lessees are notified by organizer. Notification list will be sent to organizer if event gets approval.
