CHAIRPERSONS REPORT

Judith Munoz read a brief statement she found on "Chat" regarding the De Anza Re-wild plan. Judith provided an update on the De Anza Natural Plan "ad hoc" Committee. The Planning Department added back six acres for recreational use to the plan, supporting wetlands and active recreation. Judith asked for status regarding money owed by Sea World and the Mission Bay change in dog hours and nighttime curfews at Fanuel St. Park, PB Library and Mission Bay youth fields

STAFF REPORTS

San Diego Lifeguard Service –Brian Clark from SD Lifeguards announced full summer staffing schedule has started with more staff on board. Lifeguards are working closer with SDPD to curtail illegal commercial watercraft rentals

San Diego Police Department – Lt. Bryan Brecht with Northern Division reported that PD is preparing for Fourth of July holiday with increased presence in the beach communities

Parks and Recreation

Park Ranger Report – Four new Park Rangers will be assigned to Mission Bay Park. We hope to have them onboarded by mid to late June. Park Rangers have been able to increase the abatement of unauthorized camping within Mission Bay Park with assistance from Environmental Services Department Code Compliance Officers and Neighborhood Policing, especially at the interior of Fiesta Island

Mission Bay Park District Manager, Mike Rodrigues is now sending out the Mission Bay Park events calendar to members. Portions of the fenced area of Fiesta Island are scheduled for mowing on 6/17 & 6/24. A new bench has been installed at the Kendall Frost marsh overlook. The Santa Clara playground/comfort station project is complete. There are some hardware issues for health restrooms locks that need repair. Work continues for the South Tecolote Shores playground/comfort station into the summer months with estimated completion of July 31. Vicky Hara has been assigned to the P&R Permit Center and will assist in special event permitting/management for Mission Bay Park
