501. Fiesta Island Amendment to Master Plan-Clark Taylor

Mr. Taylor spoke about the Fiesta Island Amendment to the Master Plan; the purpose, background, proposed options and next steps. The purpose of the Fiesta Island Concept Plan Amendment is to formalize uses and activities already occurring on the island, address water quality and erosion, and enhance shoreline and lower amount of developed parkland while providing additional regional recreation opportunities. There will be island wide circulation improvements; limited roadway improvements, hard surface multi-use paths, firm surface recreation trails, soft surface trails, trail bridges crossing roadways and leash free and parkland parking. Next steps are to amend current Mission Bay Master Plan and prepare program environment impact report (EIR). Two concepts will be evaluated equally in EIR, Option A: Fiesta Island General Development Plan 5f and Option B: FIDO submitted design option.
