Dan O'Neill with the Mission Bay Rowing Club shared his concerns regarding parking safety due to the large numbers of homeless and lack of enforcement at both El Carmel and Santa Clara Point

Ryan Wild also shared his concerns regarding public safety in the El Carmel and Santa Clara Point locations due to the large number of homeless individuals. He is requesting enforcement of the laws

Mike Rodrigues offered to meet with all concerned residents and tenants to discuss the increase in homelessness and safety concerns at the Santa Clara and El Carmel locations. He will include SDPD as well as Park Ranger and park maintenance staff

Love Your Wetlands Day organized by the SD Audubon Society and UC San Diego Natural Reserve held on February 5, 2022 was a success with over 600 people in attendance

Judith Munoz drafted the letter requesting a revision to SD Muni Code 26.30 relating to Mission Bay Park Committee member representation. The request is to add representatives from CD1 and remove representatives from CD6 due to recent City Council redistricting. Jeff Johnson read the draft letter which will be sent to the Mayor's Office

Michael Ruiz has been appointed as the new Department-wide Chief Park Ranger position. New Director of Appointments for Boards and Commissions is Chida Warren-Darby. Upcoming special events include the Crew Classic held the weekend of March 25–27. Santa Clara playground and comfort station construction is still underway as well as the Tecolote Shores playgrounds, restrooms and DeAnza fitness station improvement projects

Mac stated that the golf course is an affordable, valuable community established recreation resource which should be preserved

Committee members Jeff Johnson, Giovani Ingolia, Marshall Anderson, Stephanie Smith and Ron Anderson all shared their concerns about water quality, however, they do not support losing affordable active recreation such as the Mission Bay Golf Course, Campland by the Bay, Mission Bay Boat and Ski Club and children's playgrounds as part of the DeAnza Natural Plan as presented. They feel that the plan should preserve these valuable public recreation resources and include preserving Mission Bay's water quality

Mike Rodrigues stated that he received 30 emails from members of the Mission Bay Boat and Ski Club requesting to keep the Club at its current location and allow them to continue providing on-water recreation and boat storage

Chairperson Judith Munoz thanked City staff for the presentation and understands the importance of providing affordable recreation needs. But, rising sea level is real and the need for wetlands restoration is important to maintain water quality
