He stated that there is an investigation underway regarding the Peninsula Tennis Club.

<u>CITY COUNCIL DISTRICT 2 OFFICE</u> – Carrie Munson announced that the Street Vendor Ordinance has been approved at City Council and will move to the California Coastal Commission for review at the beach communities. Budget news – the May revise was adopted with many adds to P&R. CD2 Office continues to receive complaints regarding foxtails at the fenced dog area at Fiesta Island. Clairemont Family Days event will be held on September 10th at South Clairemont Park.

San Diego Lifeguard Service – no report

San Diego Police Department – The report for SDPD was made at the Improvement Fund Oversight Committee meeting.

Parks and Recreation - Mission Bay Park District Manager, Mike Rodrigues provided an update on the Santa Clara playground and restroom project which is on hold until the Fall and the North Tecolote playground and restroom project will continue work through the summer with a tentative opening set for Fall '22. Two major summer events held in Mission Bay Park include the Kai Elua Outrigger canoe races on June 24th and the 69th annual OMBAC Over the Line Championships during the weekends of July 9–10 and 16–17. New P&R Fees take effect July 1st. Changes to the P&R leadership team includes the retirement of Shelly Stowell, Deputy Director for Community Parks I Division and the interim assignment of Steve Palle for CP1. 1st Annual P&R Career Fair will be held on June 24th at Balboa Park Club. No update on park curfews or change on dog hours at MBP. Hot topics include beach fires and sidewalk vendors.

501. Sidewalk Vending Update – Coastal Areas

Chief Park Ranger, Michael Ruiz, with Parks and Recreation provided a comprehensive overview of the new Street Vendor Ordnance which was approved by City Council and takes effect June 22, 2022. The California Coastal Commission will still need to review and approve the Ordinance for the beach communities. The new regulations allow for vendors to operate with a permit to sell goods, but not services between 8:00 a.m. and 8:00 p.m. in predetermined areas. Enforcement will include addition of Park Rangers for outreach, education, administrative citations with fine and potential impounds for repeat offenders. Questions were taken from the committee and public. The use of generators for power is not allowed.
