INFORMATION ITEMS

301. Mission Bay FY 15 audit results - Shoshana Aguilar, Performance Auditor II

Performance Audit of the Mission Bay and San Diego Regional Parks Improvement Funds for 2015 was discussed. Annual Audit objectives require a report including a complete accounting of all revenues received, the amount and nature of all expenditures and whether expenditures were consistent and compliant with City Charter requirements. Objectives also include verification that Fiscal Year collection, allocation and use of Mission Bay Park lease revenues are in compliance with the City Charter.

The adjusted Mission Bay lease revenue totaled \$29,525,879.00.

Conclusion:

The expenditures complied with the Charter requirements. Prior recommendation to obtain Council's approval of the priority of projects was implemented. Audit team found that FY 2015 Mission Bay Improvement Fund post charter expenditures of \$171,848.00 were allowable and appropriate. Also found was Park and Recreation Department in coordination with Public Works should provide to the Oversight Committee a report of expenditures at least annually.

Conclusion:

The Park and Recreation Department in coordination with the Public Works Department should either modify their quarterly report to include the amount of expenditures by project, or they should modify the Power Point presentation that accompanies the report to include this information. This should be done as part of their next project report to the Oversight Committee Fall 2016.

302. Proposed Amendments and Extension to Charter Section 55.2

Consideration of potential ballot measure to extend Charter 55.2 to preserve and prioritize capital investment in Mission Bay Park and Regional Parks for an additional 30 years, provide clarifying language to expedite priority completion and implement cash management best practices and modify the disbursement formula to provide additional resources for Balboa Park and other Regional Parks.

The proposed extension to Charter 55.2 will guarantee a long term funding source for Mission Bay Park, Balboa Park and other Regional Parks, provide ability to optimally finance long-term improvements, and will more effectively pair project expenditures with annual cash flows preventing accrual of large cash balances. Because of the more efficient cash management balances, there are sufficient resources to fund all of the priority projects outlined in Charter section 55.2 without any delay and add additional resources to the Page 3 Mission Bay Park Improvement Fund Oversight Committee July 12, 2016

cultural and historic hearts of the City, Balboa Park and other Regional Parks.
